There will be a reduction in prices on most literature. A 20% decrease in the list price on pamphlets and non-book items, \$9.50 for the Big Book and \$5.00 for abridged or any other format. ### **New Business**

#### **Quarterly:**

Nic went to the Quarterly (virtually). See quarterly minutes on Area 72 website for more information. There has been less income and more expenses. Discussed best practices for digital 7<sup>th</sup> tradition. Discussed the possibility of postponing Our Stories Disclose release because it is not currently self-supporting. There will likely be a motion at the assembly. They will likely end up printing new OSD and then asking area to help. Deadline to provide group discussion regarding the upcoming conference to delegate, Alan extended until April 28<sup>th</sup>. He does not need votes from groups, just discussion.

#### 7<sup>th</sup> Tradition: Aaron

Should we accept credit card donations on website? Most every platform charges. Narrowed it down to Zelle. We can connect to bank account.

#### **Discussion:**

- Will it be a link on district website? No, likely will just include information on district website and email information. Then people can just go on Zelle and do it themselves.
- Zelle would be best because there is no fee.
- Just 4 today tried to have a code to scan and it got complicated. Would be nice to have something more simple.
- This will just be an additional way to make donations. People can still send checks.
- Aaron will put information on website. GSRs please tell groups. It will be connected to email treasurer@district32aa.org

Aaron made a motion to activate Zelle account to accept 7th tradition funds. Jean-Paul seconded. Motion passed.

## Are we doing what we can to reach newcomers during this time?

- Members have been putting their contact information into the private chat on Zoom for newcomers.
- Social workers/hospital staff giving patients information about zoom meetings at the hospitals.
- Members staying after on zoom meetings to exchange numbers with newcomers.
- Are newcomers blocked because they don't have passwords?
- Should we be using passwords and having waiting rooms? Are those barriers to newcomers or are these measures necessary for security reasons?
- There's an option to kick people out if they are being inappropriate.
- Maybe meetings don't need passwords if the rest of the settings are set up correctly (waiting room, muting, no screen sharing).
- How about the homeless population? How are we reaching them?
- Apparently the DOH allowed some meetings that were under 10 people and followed social distancing guidelines, in certain circumstances.
- But even if people can meet, what if the place to meet is no longer available? Could people meet outdoors?
- Couple people showed up at meeting location and sat in their cars to see if anyone showed up.
- Maybe put some signage on the door? QR code to take them to the website. Intergroup phone number on sign too?
- Committee chairs probably need to change nature of their work. Provide lists to treatment centers, hospitals. Maybe reach out to shelters?
- Create flyer to put at hospital to provide an easy way for patients to find out about zoom meetings?
- We should be helping answer phones for intergoup. They will forward to your personal phone.
- There's a nightwatch at Intergoup and in Pierce county central office.
- Everyone send changes to Carrie and Aaron for meetings changes so they can be put onto website.

# **Recording Zoom meetings:**

- Should we record zoom meetings?
- Purpose would be to make things easier on secretary and also would be good for archives.
- Maybe it would be good to do all the time, not just during covid19. Then we always know what really happened at district meetings.
- Do we have room for all those recordings? Yes, on flash drive.
- It would be given to archivist, not stored on the web.
- They would be in MP4 format.

Motion to record Zoom meetings passed. 14 for, 0 against, 1 abstained.
