## **STEP 12:** *"Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs."*

Every single thing about the 12 Steps scared me, especially the spiritual parts.

I could not admit to myself I needed help, so forget about admitting it to a Higher Power AND another human being!

I simply would not share - ever - my full story with another human, nor would I ever admit my mistakes and make amends to the people I had harmed while an active addict.

And the more I learned about Step 12, the more my resistance grew to sharing what had been freely given to me with another alcoholic. I was, in my mind, a special case.

I mean it took everything I had to keep me sober while completing the first 11 Steps, and now Step 12 requires me to work with others?! That suggestion was almost as daunting to me as the 50-foot-tall Step One.

But in practice, it has not been that way at all. "Contempt prior to investigation" accurately described how I operated in the world. Once I was willing to work each Step to the best of my ability, as written, in all my affairs, my perspective changed.

It took time, and commitments to acts of service, to help me recognize that the program's spiritual suggestions - prayer, meditation, humility, rigorous honesty - have made the biggest impacts on my sober life.

I can be sober without working the Steps, but I won't be happy, joyous and free unless I commit to working them all, especially Step 12.

## Tradition 12: "Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities."

The long form of Tradition 12 says that in placing principles before personalities we are "actually to practice a genuine humility" (which is a bedrock principle of all faith traditions). In the "Twelve and Twelve," Bill W. says that our experiences as A.A. members has "taught us that anonymity is real humility at work."

So what does this lofty rhetoric mean in the real world?

It means that even when there is a difference of opinion amongst ourselves, like the recent GSIG Board debate on what to do with the PPP funds, we discuss the issue calmly and in a civil matter.

We don't take to the airwaves (old school) or to Facebook (new school) to mobilize public support for our position or to trash talk about our opponents. Because our Board Members (of all persuasions) took our spiritual foundation of anonymity seriously and practiced a genuine humility, the "protective mantle which covers our whole Society," in Bill W's words, remains strong, so that "when anyone, anywhere, reaches out for help, the hand of AA will always be there."

Tradition 12 helps each of us to carry out this responsibility. Happy Sober Holidays!

#### **Concept XII**

#### By AA.org

General Warranties of the Conference: in all its proceedings, the General Service Conference shall observe the spirit of the A.A. Tradition, taking great care that the conference never becomes the seat of perilous wealth or power; that sufficient operating funds, plus an ample reserve, be its prudent financial principle; that none of the Conference Members shall ever be placed in a position of unqualified authority over any of the others; that all important decisions be reached by discussion, vote, and whenever possible, by substantial unanimity; that no Conference action ever be personally punitive or an incitement to public controversy; that though the Conference may act for the service of Alcoholics Anonymous, it shall never perform any acts of government; and that, like the Society of Alcoholics Anonymous which it serves, the Conference itself will always remain democratic in thought and action.

This Concept consists of the General Warranties of the General Service Conference. It is cast in stone; that is, although Bill leaves the door open for alterations and changes in the other Concepts and points out that the rest of the Conference Charter "can be readily amended," these General Warranties — like the Twelve Steps and the Twelve Traditions — be changed only by "written consent of three-quarters of all A.A. groups" in the world!

#### Why?

Because "these Warranties indicate the qualities of prudence and spirituality which the Conference should always possess . . . . These are the permanent bonds that hold the Conference fast to themovement it serves."

The Warranties also express spiritual principles which apply to all other A.A. entities as well.

#### **District 32 Motion for consideration**

#### Dec 2020 GSIG Motion Payroll Protection Program (PPP)

#### **Presented by**

District 32 and Evergreen South Breakfast Group, Just 4today speaker meeting

#### Motion

"GSIG will repay the entire Payroll Protection Program loan even though it has been granted forgiveness by the SBA. "

#### Background

The loan amount was \$18,179. The PPP Loan was legally forgiven by the SBA on 10/13/20.

At the May 19, 2020 Board meeting it was vote 8 YES, 4 NO and 2 Abstained (D32 and D14) to accept the PPP loan and apply for forgiveness. It passed. At the June 16, 2020 Assembly it was voted 19 Against and 15 in Favor of adding the PPP loan to the Assembly. It failed.

#### Pros

We believe it is a direct violation of the 7th tradition to accept money from any source outside of AA.

We believe while at the time the loan was taken it was done so with best intentions we believe fear of financial insecurity played a bigger role then necessary and in the time that has passed since this loan was taken out, AA's have come forward with increased contributions and once again proven we can be self-supporting.

We have contacted the SBA and they have assured us that all we need to do is contact the lender who we got the loan from and tell them the board has voted to return the money even the though forgiveness has been granted and our lending institution can contact SBA and repay it. We send a check to the bank and the bank sends check to SBA. We have contacted US Bank our PPP Lender and they confirmed. Based on the latest treasurer report we can afford it.

#### Con

GSIG would have to pay \$18,179 of its cash reserves. We will be using Group funds to pay GSIG employees for hours that were not worked during the periods from May and June when the office was closed.

#### Chair (Mike M.):

#### To Board

This is my last report for my two-year rotation as GSIG Chair and also before our GSIG Assembly that will be held on December 15, 2020 at 7 pm

As a reminder at GSIG Assembly each District and Group that attends will be eligible to vote and we will be voting on the following;

- 1) Election of GSIG officers for 2021/2022 (Chair, Vice-chair, Treasurer, and Secretary)
- 2) 2021 Budget
- 3) Proposed Amendments to Bylaws
- 4) District 32 Motion to repay PPP Loan

It has been a privilege and honor to serve as your Chair over these last 2 years. We have gone through a lot and a lot has changed in our world and the way we are able to meet and interact. In my first Chair report (January 2019) the highest priority I wanted to focus on was improving the two-way communication between GSIG and the Groups. We had a lot of challenges and obstacles to overcome and I feel like I have not been able to devote enough of my efforts on improving these communications. I would encourage the next folks that serve on the Board to try and continue these efforts. I am reminded of one of my favorite sections in the story Keys to the Kingdom.

"A.A. is not a plan for recovery that can be finished and done with. It is a way of life, and the challenge contained in its principles is great enough to keep any human being striving for as long as he lives."

It also says in our literature we are people who would not normally mix. What I will miss most as I rotate out of the Chair position is getting to regularly interact and work with so many wonderful people outside of the AA meetings I normally attend.

#### Summary

-A reminder that the PPP loan was forgiven in October, so that \$18K no longer shows up in Liabilities. When you are looking at the Condensed Balance Sheet, you will see in the top section "Net Other Income" about \$18K. This is coming from the PPP loan, but this income showing up here is a result of bookkeeping. We did not receive another \$18K in October; we received the loan earlier in the year and have already spent it. However, when it is removed from Liabilities, it is accounted for as income. So, this line item does not change the money that we actually have in the bank at all (which is why above I listed the monthly income as ordinary income, that is, the net income we get from contributions and literature, minus expenses). -The office committee suggested a change to the budget draft you saw in October: we will add \$480 for the intergroup board (to cover costs of attending the area assembly, etc.) This will then also increase the budget for Group Contributions by the same \$480, so that the budget remains balanced.

-Any other changes that come out of the November board meeting will also be updated in the budget draft, and the "final" version will be sent to you ASAP so that you can take it back to your groups and be ready to vote to approve the budget at the December board meeting.

#### Accessibility (Laurel W.)

Greetings everyone,

I'm grateful to AA for my sobriety, and grateful for the Service of chairing and interpreter coordination for the Accessibility Committee of GSIG. I'm grateful to you for my sobriety.

The Accessibility committee has been and continues to be very active this year, more so than any other time since this committee was set up seven years ago. Currently we are also reviewing our guidelines that were written when we set up seven years ago. 2020 has brought us Zoom meetings which has been a blessing for Deaf alcoholics from all over the world. There is a high demand for access to our Seattle AA meetings. The numbers of Deaf alcoholics finding our interpreted meeting keeps growing every day. A month ago, a Deaf alcoholic from France expressed her gratitude for having found our interpreted meetings. She lamented that there were no interpreted meetings in France. She saw how we do it here, and today announced that a group in France has started providing access in French Sign Language. (American Sign Language and French Sign language are not the same).

We are consistently able to hire interpreters because Intergroup board members approved funds to continue these services and as I look to 2021, we hope to continue to have funding for carrying the message to Deaf alcoholics.

In December, when the budget is discussed, I have rough numbers for what we need (at the minimum). We have two budgets: a budget for AA meetings in ASL and the second budget is for doing the business of Accessibility. The 2021 estimated budget for providing ASL for AA meetings is estimated to be \$7,680.00. The 2021 estimated budget for budget for doing business in Accessibility committee comes to \$4,000 annually. We will be happy to provide specific details as to how we came to these totals.
