There is a clear dividing line in my career as an AA member, which began more than 30 years ago. That line of demarcation is the day I became willingness to work Step Three to the best of my ability.

I've been around AA and the 12 Steps for a long time, but only recently celebrated two years clean and sober. Why?

Primarily because I would not completely embrace and/or commit to Step Three: **Made a** decision to turn our will and our lives over to the care of God as we understood God.

My ego would not let me surrender to an unseen power greater than me.

The Third Step was as big a challenge for me as Step One. I believed I could get and stay sober without doing the spiritual work AA suggested for recovery. I wanted to think my way out of my misery instead of taking AA's suggested actions.

I was a living example of the ineffectiveness of half measures.

Alcoholism is rampant on both sides of my family. It killed my brother and an uncle. I also had witnessed people close to me turn their lives around, dramatically, by following the Steps. My dad died with 49 years in the program. My best friend, Bob, celebrated 38 years last April.

But none of that was enough to persuade me to follow the Steps as written, even though I loved meetings right from the start. I identified with the people I met and the shares I heard at meetings. I knew I belonged in the rooms. I read the literature and managed to stay sober for various lengths of time more than once.

But, as always, I was trying to do things my way. I did not want to admit I needed help, especially from a Higher Power. I definitely did not want a sponsor. I was afraid of that kind of accountability. I did not want to work the Steps as written. I wanted to skip or ignore the "God" parts. I conflated Higher Power with religion.

I wanted to believe AA's 12 Steps were not for me - until my Higher Power hit me between eyes with the gift of desperation. I finally admitted to myself that my life had become too dark, lonely, hopeless and dangerous for me to change it on my own.

Everything I'd heard in meetings clanged in my head. We can't do it on our own. I needed help.

On the morning of Jan. 7, 2019, when I was feeling especially desperate and vulnerable, my thinking changed. I was literally driven my knees, where I said a short but sincere prayer: God, please help me!

I was finally ready to try Step Three after years of saying No!

I didn't say Yes! I said Maybe, and that was enough to open the door to willingness.
