

FEBRUARY IN OUR HISTORY

- February 2 1942 Bill W. paid tribute to Ruth Hock, AA's first paid secretary, who wrote approximately 15,000 letters to people asking for help
- February 8 1940 Bill W., Dr. Bob, and six other A.A.s asked 60 friends of John D. Rockefeller, Jr. for money. They got \$2,000.
- February 9 2002 Sue Smith Windows, Dr. Bob's daughter died.
- February 10 1922 Harold E. Hughes was born near Ida Grove, Iowa. After his recovery from alcoholism, he became Governor of Iowa and a U.S. Senator.
- February 11 1938 Clarence S. ("Home Brewmeister") had his last drink.
- **February 12** 1945 World War II paper shortage forced reduction in size of Big Book.
- February 13 1937 Oxford Groups "Alcoholic Squadron" met at the home of Hank P. ("The Unbeliever" in the 1st edition of the Big Book) in New Jersey.



1940 – With about two years of sobriety, Jim B. ("The Vicious Cycle") moved to the Philadelphia area and started the first Philadelphia A.A. group.

Feb 14 1971 – AA groups worldwide held a memorial service for Bill Wilson.

2000 – William Y., "California Bill" died in Winston Salem, NC.

February 16 1941 – Baltimore Sunday Sun reported city's first AA group begun in 1940 had grown from 3 to 40 members, with five being women.

February 18 1943 – AA's were granted the right to use cars for 12th step work in emergency cases, despite gas rationing.

- February 21 1939 400 copies of the Big Book manuscript were sent to doctors, judges, psychiatrists, and others for comment.
- February 26 1999 Felicia G., author of "Stars Don't Fall," died.

Step Two: "Came to believe that a Power greater than ourselves could restore us to sanity.

In the AA meetings I attend, Step Two gets the star treatment in February, and rightly so.

About this time more than two years ago, I attended an hour-long men's meeting where the chairperson spoke for about 10 minutes on the importance of Step Two for AA veterans and newcomers alike.

My sober birthday is Jan. 7, 2019. Every day it becomes clearer to me that I need help with my thinking. I need AA's literature. I need lots of meetings. I need to work the Steps to the best of my ability every day. I need the example and support of my sponsor. And above all else, I need the help of a Power greater than myself to live and act sanely.

(And did I mention the need to attend lots meetings, so I can hear and see what happens to people who do not attend meetings.)

For me, the key to Step Two is the belief that a Higher Power can prevent me from



acting out my self-centered, completely unhinged and overly emotional impulses.

I understand why I hear people at meetings frequently say, "My best thinking got me here (to the rooms and Zooms of AA)."

The meeting chair said Step Two promises that people who rely on the God of their understanding can change their lives for the better.

When he opened the meeting for sharing, the focus shifted to colorful examples of how insanely people acted in active alcoholism. It was an intoxicating cavalcade of wrong-headed, clearly insane thinking by people under John Barleycorn's influence.

Among the examples shared: getting into fights at bars; getting into fights with police, while handcuffed; riding a motorcycle the wrong way on a freeway; leaving treatment to attend a party; a prodigious week-long binge that crisscrossed all U.S. time zones; associating with dangerous people — on purpose.

Laughter echoed about the room as one storyteller after another tried to top the earlier shares. Naturally, the meeting morphed into a brag-a-thon of insane behavior.

One guy talked about breaking an ankle jumping a fence at a zoo to mess with the big cats, which, luckily for him, were bedded down in a locked building. "It seemed like a good idea at the time," he said.

But the next guy's share shut the room up and popped the ain't-that-hilarious bubble!

"The most insane thing I did was think I could drink like a normie after being sober for almost five years," he said, his face serious. "I just wanted a cold beer on a hot day."

When he paused to compose himself, you could hear the battery-powered clock's tick-tock.



"Lost my wife ... my kids ... walked away from my home and my job, of course," emotion contorted his face and choked his voice. "Lost my self-respect and spent six months in jail (due to a DUI auto collision that injured the driver of the other car)

"All because I thought I knew what I was doing ... That I could trust my thinking. I was lost the moment I decided to have one ... one drink led right back to where I left off."

He added that it took him more than five years to return to AA. That day I heard him, he said he had 15 months clean and sober.

His cautionary tale hit home with me. I can fully admit, today, that I am an alcoholic whose thinking can be completely insane whether I am drinking or sober. I need help remembering I cannot rely on my thinking. For me, the enemy lies within.

I need to turn to my HP and our fellowship for help when considering all my actions, big or small.

Tradition 2:

For our group purpose there is but one ultimate authority - a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

I've seen and felt the full force of Power of Alcoholics Anonymous' Tradition Two, which is a brilliant example of the wisdom and practicality of AA's all encompassing keep-it-simple philosophy.

Time and again, I am amazed how leaderless groups of self-identified drunks can remain united and effective at their primary purpose (carrying the message to suffering alcoholics) in the face of divisive pressure to reach consensus during a public health crisis

I have been massively impressed by how two AA groups I am deeply involved with have dealt with the restrictions, aggravation and controversy of conducting meetings while a global pandemic rages.

The groups — the Magnolia Speakers Meeting and Empire Way — are mainstays of the Greater Seattle Intergroup of Alcoholics Anonymous (GSIG), yet each, like all of GSIG's meetings and groups. have taken different approaches to holding their meetings in this time of Covid-19 and its variants.

Some groups are Zoom only. Some only meet in person. A few have two meetings — meeting separately inperson AND online. And some simultaneously meet via Zoom and inperson.

GSIG cannot tell groups how to run their meetings. It issues no guidelines or masterplans or rules that all groups must follow. Many groups are still evaluating how to proceed in the face of an ever evolving situation. The



MSM and EW meetings are both member groups in good standing with, but their constituencies are different, which is reflected in their current operations.

The Magnolia Speakers Meeting conducts only in-person meetings at Magnolia Lutheran Church, it's home since 1980 (Fridays at 8 p.m.). The Empire Way group, which was founded 74 years ago, uses a hybrid format: members can attend meetings in person at Our Lady of Mount Virgin Church or participate via Zoom at 8 p.m. on Mondays and Tuesdays.

MSM serves coffee and cookies. Empire Way does not. Much of that is determined by rules handed

down by the landlords where the meetings are held.

That the groups chose their meeting formats illustrates how broadly decision-making power is dispersed among AA groups locally and how the organization relies on its democratic traditions to ensure the group conscience is achieved and accepted.

I served as Empire Way's business meeting chairperson through December 2021. Whenever potential changes to the meeting's format were discussed, emotions ran high, as members who favored a return to in-person only meetings and those who wanted to keep the hybrid format fully, vigorously expressed their views. (Yes, I was grateful EW members no longer drink.)

At the January EW business meeting, it was decided to put off a decision on changing the format for five months to see how the Omicron outbreak proceeds.

I marveled that Empire Ways unity survived the tumultuous discussions, but that's because I am a relative AA newcomer (I recently celebrated my third birthday). Long-time members were not.

They had faith that my beloved leaderless drunks would make wise decisions as envisioned in Tradition Two mainly because of Tradition One, which states: "Our common welfare should come first; personal recovery depends upon AA unity."

We Did It!

When COVID hit, everything went haywire — kids, stress, technology — you name it. AA to the rescue

The moment I knew the COVID pandemic was going to be a major disaster was when my kids were sent home from school. The governor said we had to shelter in place, and all of a sudden my AA meetings couldn't meet in person.

I immediately went into disaster mode and started controlling everything in my life—the kids' schedules and happiness, the cleanliness of my kitchen, my mother's and my sponsees' wellbeing. Have no fear, Kelli is here!



That was my motto, which lasted about 14 days, until I had this moment of clarity and realized that we might be shut down for a while and my behavior wasn't sustainable or helpful. As with every other disaster that has struck during my sobriety, I turned to AA for answers.

Our First Tradition has been the greatest help for me during this time: Our common welfare should come first; personal recovery depends upon A.A. unity. When applied to my life, it reminds me to put the well-being of others first. The common welfare of my family comes first. The common welfare of my community comes first. It's my job to ensure that I don't pass along the COVID-19 virus to someone else. It's my privilege to think of how I can help meet the needs of my family and community.

Right away, my home group began meeting online. We struggled to mute and unmute, to teach the oldtimers how to use the technology and to connect in fellowship so we wouldn't separate. But I found myself finding fault with our meeting, with how people had set up their cameras, talking with the volume up or down, you name it. I was finding fault with everything. Again I thought, This isn't sustainable or helpful.

So I picked up my spiritual AA toolbox and tried to be of service. The regular service positions in my meeting had changed, so I reached out to members to see how they were doing or to tell them I missed seeing them. I reached out to people after they shared to tell them how much I appreciated what they said. I ended up developing amazing new relationships. I began to feel so fulfilled and supported just by supporting others.


One of my home group members is a photographer and he has begun texting me a photo every morning. It has turned into part of my Eleventh Step morning meditation time and is something I look forward to every day—another unexpected gift as a result of reaching out to others.

There have been many times when I feel like this pandemic will never end. Sometimes I think it's all too much and I can't do this anymore. I'm tired and lonely and overwhelmed with the stress of it all. But then the principles of our program have helped me. I can't live in this shut-down pandemic world forever—but I can live in it today. Just for today I can follow the rules, limit my activities and do the things to keep myself and others safe. Just for today I can live life on life's terms. Freedom from the bondage of self has come from being of service to my home group and sponsees.

One of my sponsees started a new meeting for our sponsor family and we have women from all over the country who come together to meet online once a week. It has become a favorite meeting for us all.

There will likely be more disasters and emergencies as I move forward in sobriety. Living one day at time, putting first things first and approaching life on life's terms will see me through again and again, just as it has these past two year.

Group contributions are 2.3K below monthly budget, year to date group contributions are 15.8 K below budget. YTD net loss is 16.6K. As the chart above shows the cash in bank has only declined 11K. The last physical inventory was done in 2018. On Dec. 30th we did a physical inventory and wrote off 6.5K literature we don't have, as well as the Spanish pamphlets and unsalable books. My important point for the year 2021 – Groups, Personal, and Sustainers provided \$166K. Our expenses exclusive of literature sales were 182K. If GSIG is to prevent a continued decline in our cash in the bank we need to let the fellowship know we need more income in 2022. How much more – Our cash in the bank decline tells the story. If we get \$900 more a month income we will stop the decline.

Chair (Astri):

It was so great to see so many of our groups and districts represented last month at our Fall Assembly.

I hope you all enjoyed the winter holidays and that you made the most of our first blast of winter weather.

January 7th and 8th, I attended the Area 72 Business Quarterly in Sequim. It was a Hybrid event, I attended in person. Friday evening I facilitated the Area 72 Group Inventory, a two hour process. The inventory will be written up and action items will be identified.

Saturday morning, business began at 8:30AM. Area Treasurer report and 2022 proposed budget were approved. Special Reports were given, and I presented the GSIG Report. Creating a new Spanish Linguistic District was discussed, a motion was made to move the issue to the 2022 Assembly as a motion. Giving the Area Archivist position full Right of Participation in Area 72 Quarterlies and Assemblies was also discussed and was moved to the Assembly Agenda as a motion as well. There were two Discussion Topics on the Agenda; 1) What is an Area Event? What resources are allocated to Area events? 2) Do we want to invest in equipment to hold hybrid Area events in the future. DCMs were asked to take these topics back to their Districts and Groups for input, there will be further discussion at the April Quarterly.

In addition to the above, I continue to co-facilitate the monthly, Hybrid, Service Manual Study at GSIG and participate in additional service activities as requested. Going forward, I've been asked to present at a CPC Quarterly and to facilitate a Group Inventory for an on line only group.

GSIG has done a Group Inventory every rotation and it is time to start planning for that. The event is usually not held during a Board meeting. I am suggesting a weekend day in March and will be asking you to weigh in as to what day and what time you would prefer the event to be held.

I thank you again for your service and for providing me with this opportunity to serve you and Greater Seattle AA.

Minutes of January 2022 GSIG Office Committee Meeting

Review of December and end-of-year financials by Carl G. Discussion of annual loss of an average of apx. \$900 per month, not counting literature write-offs, and need to explore more ideas for growing 7th tradition participation by individuals and groups in 2022

Proposal made by Lara to not print schedule books in January, due to lack of demand and continuing changes in meetings. Approved unanimously. Followed by proposal by Carl G to adjust the 2022 budget proposal to reflect no January schedule printing. Unanimously agreed to recommend this change at the December Assembly.

Office Manager's report by Lara

Committee agreed to support the addition of alternative payment tools for donations, such as Venmo and CashApp.

Discussed of plan for reviewing office procedures in the GSIG Policies & Procedures manual, as requested by the 2020 Committee. Committee agreed that Anita and Lara would do an initial review for two weeks and then post their changes/recommendations in a shared Google doc. The rest of the Committee will then have two weeks to make notes and edits, and final version will be done at February Committee meeting.

Discussed open seat on the Committee and agreed Committee members would all help search for candidates.

Discussed plans for a GSIG group inventory. Agreed that the inventory should be on a separate day than a Board meeting, and that Astri would poll the people present at the next Board meeting about date and time preferences.

Office Manager (Lara R.):

Financial: Our physical inventory was completed at the end of December. Thank you to the volunteers who dedicated their time towards this endeavor. Much like our personal inventories it is nice to set the record straight and start fresh with our liabilities behind us.

There are still many shifts available for answering phones during closed office hours. If your group is looking for a place to fellowship and do service at the same time, this is a great way to do it. Your group can answer phones in the office, or the phones can be forwarded to a personal phone

number. Some groups have established a Google Phone number for this purpose. This is a free service that Google offers. If your group would like to sign up for this service opportunity please reach out to Anita or Lara and we can let you know which shifts are open.

We answered 30 12th Step calls last month.

We have a tentative date for the Big Summer Picnic of August 21st. We will let you know as soon as we hear anything definitive from Seattle Parks.

Web & Technology Committee (Dan G.):

PI/CPC Committee (David D.):

We are collaborating with Hospital and Treatment and Elizabeth Gregory and other projects

We are encouraging PICPC Committee members, and others in AA, to identify potential schools, hospitals, senior living spaces, libraries, and other places that that might benefit from the AA message.

We also encourage attendance by anyone interested at the PICPC committee meeting, held the third Saturday of the month at 10:00 AM, especially from district PI or CPC representatives.

District 14 (Kim S.):

Our DCM reports that he has attended the business quarterly and discussed the upcoming preconference and General Service Conference. PRASA is online this year and will the 1st weekend of March and they are looking for volunteers.

Our Alt DCM also went to the quarterly and is currently working on getting us our GSR kits.

Language of the Heart reports that their meeting Is growing.

We have a new GSR here for the first time to learn.

There are tons of service education, preconference and GSR classes coming up. To find out more go to area72aa.org

We discussed having a D14 group inventory in the future.

Our open committee chair positions are: corrections, grapevine/literature, web chair and young people's chair.

Accessibilities chair says that he has accessibility checklists for groups available online at area72aa.org. Please contact him for any accessibility needs.

Archives- if you have any literature or other items of historical interest from your meetings, he would love to have them to add to our archives. He also is looking for anyone who would like to share oral histories of experience, strength and hope.

CPC- They had quarterly in November. They voted for making some changes to PICPC and there is more to come about this.

Schedule changes are done on a daily basis so please if you need to call twice or three times a day go ahead inform GSIG: you may of just helped a person get to an meeting and not get a locked door or room.
