MAY IN OUR HISTORY

May 2

1941 – Jacksonville, FL newspaper reported the start of an AA group in Jacksonville.

May 3

1941 – First AA group formed in New Orleans, Louisiana.

1941 – Democrat Chronicle in Rochester, NY, reported first annual AA dinner at Seneca hotel with 60 attending.

May 4

1940 – Sunday Star reported founding of first AA group in Washington, DC.

May 6

1939 – Clarence S. of Cleveland told Dr. Bob, his sponsor, he would not be back to Oxford Group meetings in Akron and would start an "AA" meeting in Cleveland.

May 7

1956 – The first English AA Convention was held in Cheltenham, England.

May 8

1943 – Akron AA Group celebrates 8th anniversary with 500 present and sober.

1971 – Bill W. was buried in private ceremony, in East Dorset, Vermont.

May 10

1939 – Clarence S. announced to the Akron Oxford Group members that the Cleveland members were starting a meeting in Cleveland and calling it Alcoholics Anonymous.

May 11

1935 – Bill W. called Walter Tunks from the Mayflower Hotel, and was referred to Henrietta Seiberling who set up a meeting with Dr. Bob.

1939 – First meeting of the Cleveland Group.

May 12

1935 – Mother's Day, Bill and Dr. Bob met for the first time, at the home of Henrietta Seiberling.

May 17

1942 – Dayton Journal Herald published pictures of AA members wearing masks to protect their anonymity.

May 18

1939 – The first group to call itself A. A. is meets in Cleveland, OH.

1950 – Dr. Bob told Bill W. "I reckon we ought to be buried like other folks." He wanted no memorial.

May 19

2000 – Dr. Paul O. died at the age of 83. He was author of "Acceptance Was the Answer" in the 4th edition of the Big Book. This story was titled "Doctor, Alcoholic, Addict" in the 3rd edition.

May 29

1980 – "Dr. Bob and the Good Oldtimers" was published.

May 31

1938 – Bill W. and other A.A.s began writing the Big Book.

Taking Down Barriers


The chapter on Step Five in our "12x12" talks about my sense of isolation. My feelings of anxious apartness and loneliness. From early childhood on, I remember feeling that I didn't fit in. I became a noisy, good-fellow, show-off, craving companionship and connection, but never getting it.

I didn't know being separated from other people is a symptom of alcoholism.

When I surrendered to my disease of alcoholism and entered recovery, I was left with a huge fear of people. Drinking wasn't there for me anymore, acting as a buffer to mask how uncomfortable I was around people.

My initial AA meetings were terrifying.

When I worked my way through the 12 Steps with my sponsor, I had no clue about the massive transformation that would occur within me.



Sitting with my sponsor for hours, talking through my Step Four sex inventory and fears list was the beginning, clearing away the obstacles blocking me from connecting to the world of people. I was so used to feeling isolated and alone I hadn't known how abnormal and destructive it was.

Step Five was the start of my new life and the start of understanding myself. It was the beginning of personal humility, forgiveness and compassion. It was a revelation that I don't need to always impress or amaze people.

I can just be and be OK.

One of my recovery friends was told that our AA program is "Spiritual Drano." I'm grateful I was willing to work through the process and that most of my gross and messy clogs are flushed out. I can move forward with healing, living and growing. Life today is full and busy. Every day I feel connected to other people and my Higher Power. Thank you, AA!

No matter how far down the scale we have gone ...

The Fifth Step was life changing in many ways. The two most powerful were that someone knew my deepest, darkest secrets and didn't reject or



abandon me. The other was that identifying my defects allowed me to change them.

One common theme throughout my Fifth Step was my fear of abandonment. If you really knew how horrible I was, you would leave me so let me keep up the facade and be the fake and superficial people-pleasing person you want me to be. Funny thing is that when I am fake, superficial and people-pleasing, no one wants to be around me! My fear created this horrible cycle which resulted in painful loneliness. My sponsor was the first person with whom I was completely honest. The first person who knew all the ugliness and loved me anyway. What I realize (after hearing many Fifth Steps) is that along with the defects and alcohol-fueled selfish behavior is the rest of me.

The rest of me is worthy of love. Who knew?! The unattractive, undesirable manifestation of my disease obscures the real me. My sponsor saw it all and her love helped me see it too.

When I started my Fourth Step, I was a victim and when I finished my Fifth Step, I was the victimizer. Somehow, I thought that process would be horribly painful, but actually it was completely freeing. If my life is painful because of all your defects; I will never be able to change it. If my life is painful because of all my defects; I can change each one (with the help of the rest of the Steps). By seeing that no one wanted to be around me due to my fake, superficial, people-pleasing, selfish behavior I now knew what to pray for ... the opposite! I could practice being authentic, honest, interested, unselfish, and a good friend. I could practice connecting to my Higher Power as my source of well-being, not other people and their opinions of me.

My Fifth Step showed me I wasn't broken, I was an alcoholic who exhibited selfish, alcoholic behavior that no one wanted to be around. By seeing this truth, and realizing there was goodness in there, too, I was able to continue the Steps, get closer to my Higher Power, change my behavior and change my life.

Tradition Five: "Each group has but one primary purpose — to carry its message to the alcoholic who still suffers."

Fear was the main reason I became an alcoholic. I lived in self-inflicted turmoil and misery because I was trying to control people, places and things via the use of ego, alcohol and drugs.

And despite working the Steps to the best of my abilities, the generous help of my sponsor, the example and support of other members of Alcoholics Anonymous and a practice of daily prayer, my fears and character defects are blazing brightly today as I contemplate Tradition Five.

I know the solution will be found in our program's suggestions. I have to surrender.

To Zoom or not to Zoom at meetings remains a question for many groups and members of AA. It's obvious to me that the membership has a wide array of passionate opinions about the best way of fulfilling our "primary purpose."

It's a sign on my unwillingness to completely turn my will and life over to a Higher Power that I worry about this.

It's like I've forgotten how my life has changed since I've begun to practice our program's principles in all my affairs, especially it that relates to the daily operation of our society. It's obvious that my first thoughts on this topic, and other issues, like the anticipated delivery of a fifth edition of the Big Book, are likely incorrect and unhealthily self-centered (pronounced fear).

I'm choosing to overlook how relying on all 12 Steps and all of the 12 Traditions has saved my life and the lives of millions of others because I think I know the BEST way (pronounced Only) to deliver our message of recovery.

I am the guy whose best thinking took me to a place where I needed the intervention of a Higher Power to cope with life on life's terms. Clearly, I am overvaluing my own opinions and experiences. I'm an alcoholic, so it does not immediately come to my mind that I could be wrong — again.

I'm forcing myself to study this situation, and my reaction to it, as objectively as I can. I need to look at things honestly and with an open mind. I need to be aware of my expectations. I need the input of others.

Lately I am getting comfort today from a saying of a deceased member of our club used to say in moments of fear-fueled doubt: "If you're worried pray; if you pray, don't worry."

For me, that's easier to write than practice, but I must practice it to be happy, joyous and useful to others members of our program, which is about We, not Me.

After my home group's group inventory, I was worried that the debate over how we go forward with fulfilling our primary purpose (with or without Zoom) would tear of us apart, but I have to deliberately

ignore AA's and our group's histories and philosophies to indulge those thoughts.

Like the surviving passengers of the Big Book's ocean liner, we share a powerful bond that is enhanced by our reliance on a Higher Power and our gratitude to be sober.

Things may get loud and bumpy as this issue is resolved, but I have faith our Higher Power and AA unity will see us through.

12th Step Committee Proposal

Below is a proposal from the 12th Step Committee that will be voted on at the 2022 Spring Assembly (June 21).

The 12th Step Committee was created to handle 12th Step Call requests during the hours that the Seattle Intergroup Office is closed.

The 12th Step Committee will consist of the Office Manager, the Assistant Office Manager and at least two other appointed volunteers. This position is a 1 year commitment. The initial appointed (two) volunteers will be assigned to a 1 year term and a two year term respectively.

This Committee is not limited to only 4 members. More members may serve on this Committee.

The Committee will appoint a 12th Step Coordinator or Chairperson.

This position will:

facilitate monthly committee meetings

gather contact information from AA members/groups for in person 12th step calls

delegate other members to answer emails and 12th Step requests

facilitate quarterly 12th Step Best Practices training sessions for members that have made themselves available for in person 12th Step calls.

The order of dispatching 12th Step Calls

An alcoholic requests help

The nightwatch volunteer takes the caller's information

The volunteer will then contact the 12th Step Coordinator by phone first or by email if not available by phone.


The 12th Step Coordinator will receive the information and dispatch a 12th Step Call from the 12th Step list.

It is crucial that all volunteers that have made themselves available for Twelfth Step Calls complete the Twelfth Step Call Best Practices training session. These sessions are provided by Seattle Intergroup's Twelfth Step Committee on a quarterly basis, at a minimum, and more often if deemed necessary by the Committee.






