## **Step Eight: “Made a list of all persons we had harmed, and became willing to make amends to them all.”**

In some ways, making a list of “all” people I had harmed was more daunting than actually making amends to the people on my list. I would have never completed Step Eight without the help of my sponsor, he helped me keep the task in the proper perspective.

Left on my own, I would have overthought the Step Eight requirement (make a list, be willing) and ultimately stopped doing to the work.

I was hesitant and intimidated because I was confused about how Step Eight and Step Nine actually work. In my mind, I was going to do both at the same time: I was going to make the list and immediately jump into making amends. That’s not how it works.

The first thing my sponsor made clear was Step Eight requires me to make a list and be willing to make amends to the people listed. I was much relieved to learn Step Eight would identify for me the people I absolutely had to make amends to, those I could not or would not contact directly and prioritize the order of the amends I would make



Clarifying what I was being asked helped me put aside my fears and place my faith in the process and my sponsor.

He said focusing on willingness to make my amends was the main goal. After completing the list and identifying the amends I would make set stage for success in Step Nine. I was still fearful of starting Step Nine, but by talking extensively with him during Step Eight, I was able to develop and execute a plan.

There is a reason the Steps are in a certain order.

# **Tradition Eight: "Alcoholics Anonymous should remain forever non-professional, but our service centers may employ special workers."**

It's interesting to me that money issues come up a few times in our Traditions. It's also interesting to me that Alcoholics Anonymous can clearly see and predict an alcoholic's behavior. The Chapter on the Eighth Tradition in The 12x12 says "money and spirituality do not mix ... Every time we have tried to professionalize our Twelfth Step, the result has been exactly the same: Our single purpose has been defeated."

When I first starting working with my sponsor, she said to me, "I promise to give you as much time that is required for you to work through the steps, provided you make two promises: 1) that you will do the same for others, and 2) that you will never receive money for passing on your experience and knowledge of the 12 Steps." When speaking about people who are paid by AA, The 12x12 says, "The job was not to *do* Twelfth Step work; it was to make Twelfth Step work possible."

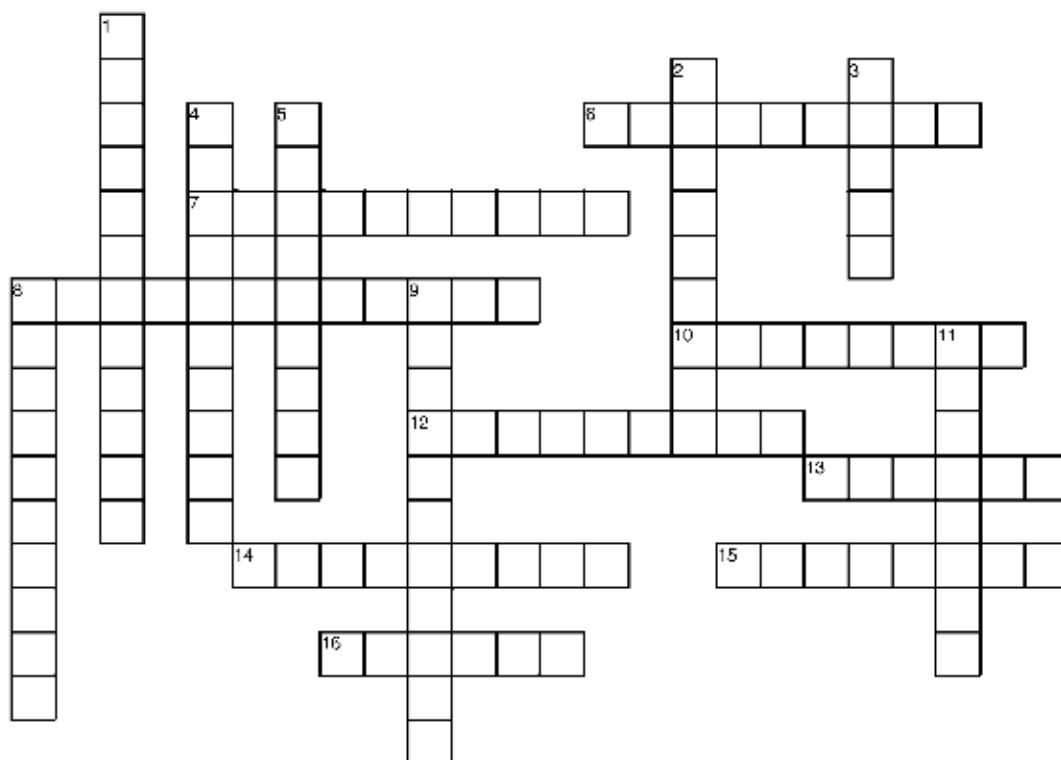
When I got sober, I went through a treatment center. The counselor was also sober. She made it clear that she was working for the treatment center, not for AA. I had a Big Book and did Step work in treatment, but she was not an AA employee. I'm grateful my introduction to AA happened early on and through the treatment center. I'm also grateful she was not a paid representative of AA. It would have clouded my judgement and tainted my view of AA going forward.

I will be forever grateful for those first 100 members of Alcoholics Anonymous and all who came and went in those first few years. Their mistakes and lessons learned, created these Traditions which protect AA today. For that, I am very grateful.

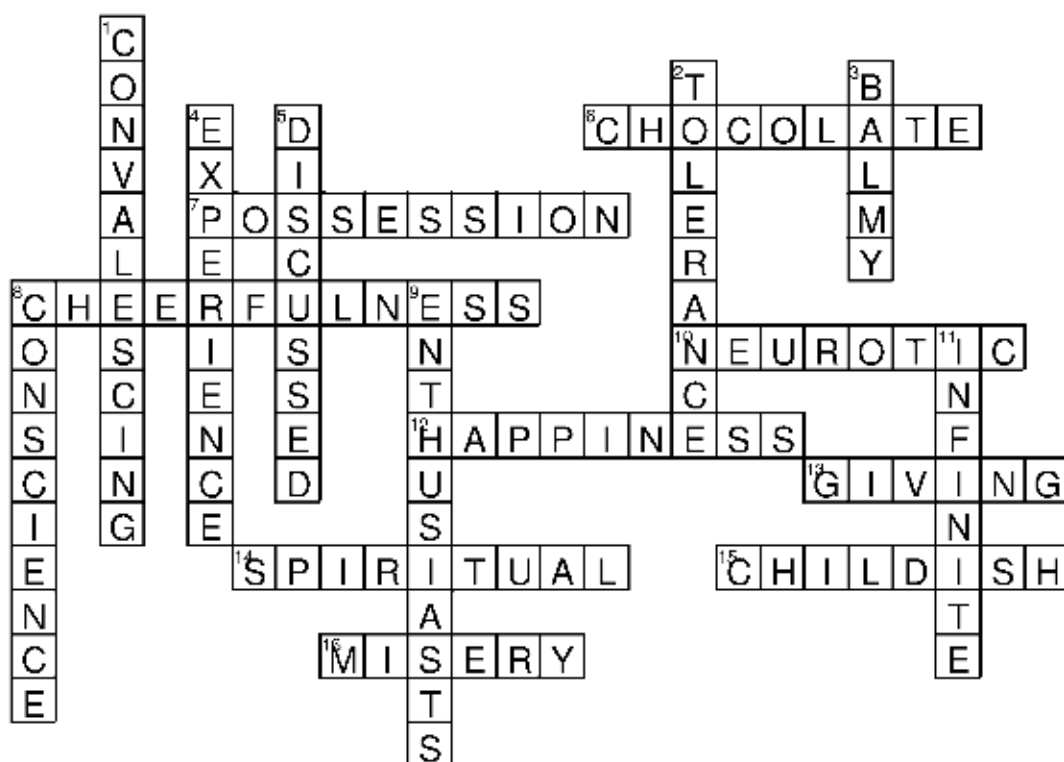

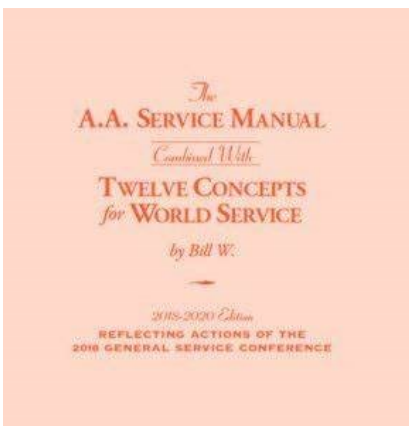

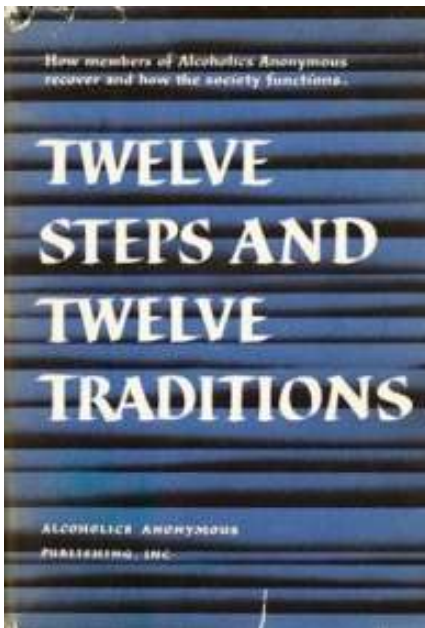
