Step Ten “Continued to take personal inventory and when we were wrong promptly admitted it.”

I’ve always been someone who wanted maximum results for minimal effort. Yes, that is one way of describing the dreaded half-measures highlighted in Chapter Five’s “How It Works.”

That max-results-for-minimum-effort philosophy of participating in AA netted me nothing but misery and more drinking. Even though I was experiencing the program’s promised benefits after completing Step Nine, my life was undeniably better because of the Steps, I still thought I deserved a break from our program’s one-day-day-at-a-time work ethic.

When I’d completed all of my Step Nine amends, I got busy patting myself on the back. I’d worked steadily on the first nine Steps and thought I deserved a break, so I did not immediately start on Step 10.

My sponsor disagreed and on a regular basis, almost robotically, gently suggested I commit to making a nightly inventory — of my day’s successes and failures — a part of my life. I know now he detected some slippage in my program

If I’m honest, I was put off by (pronounced: resented) Step 10’s requirement that it must be performed every single day. Every single day? Really? Seriously!

It took me more than two months to find the willingness, and an app, to make a nightly inventory a hardwired part of my daily spiritual practices, just as important as my morning prayer, daily gratitude list, which I share with others, and meditation practice.



In many ways, Step 10 is the most important for me. The 10th Step practice helps me see when and where my character defects escape my control.

That awareness showed me the things I needed to change in my interactions with people, all people.

Step 10 is a big reason I frequently experience joy, happiness and freedom.

TRADITION TEN: “Alcoholics Anonymous has no opinion on outside issues; hence the the A.A. name ought never be drawn into public controversies.”

Like all A.A. members, I have more than one persona. And I love how the Twelve Traditions of Alcoholics Anonymous make it easy for all of me to differentiate the boundary between me, a member of A.A., and the me that is a typical self-centered member of the emotion-driven human race.

Like a shot upside my head, Tradition 10 tells me I must leave the world and its problems, issues and controversies outside our meetings halls and off our Zoom screens. Failure to do so is a risk to sobriety, our most treasured possession.

Bringing the outside world into our midst imperils our primary purpose, that we share our message of recovery with the still-suffering alcoholic. That is our calling.

This Tradition doesn't mean our membership is monolithic and docile. Attendance at an AA business meeting, where hot, conflicting opinions are exchanged loudly and enthusiastically, will quickly dispel that notion. If you are like me, you are much relieved these people at the business meetings are no longer drinking

It is easy for most of us to see that political and social issues have no place in our meetings and group, but the existence of this Tradition is proof that hasn't always been the case and that divisive issues still pose risk to our society.

Issues like potential revisions to AA literature and others are out there. I am grateful we have the Traditions and Steps to help us navigate new and uncertain situations.

AA meetings in British Columbia are AA meetings worth your time and attention

I love meetings! Attending meetings is a cornerstone of my recovery. I did additional work to fortify the base of my program by attending meetings in Vancouver, B.C. recently.

It would be fair to say I've become addicted to AA meetings. My sober date is Jan. 7, 2019. As I write this, I've been sober 1,359 days and I've attended 3,692 meetings.

My definition of a meeting is generous. As my dear old, AA-loving dad used to say, any time you have two drunks and a resentment, you have a meeting. I also count time spent on my numerous service positions as meetings. Any time I am sharing or listening to the message, that's a meeting.

But I also attend a lot of meetings in-person and on Zoom. I am retired. I have the time. I have three AA home groups, and two home groups in another 12 Step program.

Some might say that's excessive, but when I was actively using, I spent every waking moment drinking, recovering from drinking or thinking about my next drink

Nothing revs me up more than attending a meeting when I'm away from the Seattle area.

I recently traveled to Vancouver, B.C., the site of the 2025 AA World Conference, to spend the day in meetings there. It was a fabulous experience which refreshed and inspired my soul. It wasn't because it was different from how we "AA" here. It was because it wasn't very different at all. It's all about sharing our experiences, strengths and hopes.

The only real difference I detected was how they started the three meetings I attended. After asking about visitors, they said, "Is there anyone returning (to AA meetings)?"

Personally, I really liked that touch. A couple of times, people reported that they were.

My only disappointment was that the people at the meetings did not speak like I how expected Canadians to speak. Forgive my stereo-typing tendencies, but I only heard

one person say “eh!” and he was making a joke when he said it. (Probably because there was a Yank in the room.)

They all laughed. I grimaced.

Otherwise, I felt right at home. I was with “my people,” hearing what a drunk-addict needs to here to stay sober.

I heard my favorite quote from the trip at the first meeting I attended.

“I’m Josh and I am an alcoholic trying to quietly go about the business of staying sober,” a man said while introducing himself before sharing. I wish I’d said that. It’s a great goal.

I have one complaint, and it’s minor (Resentment Alert): I didn’t like how I was treated by the Canadian Customs agent when I honestly answered her question about the reason for my visit: to attend AA meetings.

She asked several questions about my driving record and several more which sought to clarify why I would to drive from Seattle to Vancouver attend meetings.

“Mostly, it’s fun for me to meet and listen to others in recovery,” I said, as earnestly as possible.

She paused several seconds, looking me straight in the eyes a la Clint Eastwood’s Dirty Harry, before saying, “OK, drive safely.”

Canada has a policy that makes it difficult, but not impossible, for visitors with drunk driving convictions to enter the country. There are websites, like ArriveCanada, explaining the policy in detail. I recommend checking ahead of your visit if you have a DUI conviction.

I’d hate for you to miss a meeting that could change your life or someone else’s.

GSIG Corrections Committee Updates

The great news from Corrections is that more facilities are starting to open up for in-person and/or zoom meetings! The committee's email for anyone interested in learning more about service with the committee and info about how to do it, please contact

volunteercorrections@gmail.com.

If you haven't been involved in corrections service before, it can be different from other types of service. There is a formal application process that includes a background check, specific criminal history and sobriety requirements. Each facility's process is different. Then there is an orientation before being able to enter the facility. It's a process that takes time and the corrections committee has members who are very willing to help you through this process.

"We need many people who are willing to participate in meetings long enough to understand what is going on and how strong the need is for us to be there," said a person who has done this service for many years,

Here's what has been happening over the past several months:

SCORE Facility in Des Moines:

Women's meetings are held in person each Saturday at 2:30 p.m.

Men's meetings are on hold until more staff are hired at SCORE.

For more information on eligibility and application procedures, email Cynthia H at volunteercorrections@gmail.com.

Juvenile Detention Center in Seattle:

Girl's meetings are being held in person on the second and fourth Thursdays at 7:00 p.m.

Boy's meetings: Staffing issues are preventing meetings from being held. The JDC is working on hiring more people.

For more info on eligibility and application procedures, email Pam H. at volunteercorrections@gmail.com.

Federal Detention Center: This facility has re-opened and is working with the Corrections Committee on setting up in-person meetings. There is a big need for sober alcoholics who are willing patient, committed and dedicated to taking meetings into this facility. The FDC really needs women volunteers who are willing to "stick with it."

From one person who has done this said, “We need many people who are willing to participate in meetings long enough to understand what is going on and how strong the need is for us to be there.”

King County Jail: The jail is currently closed for any sort of visitation or meetings. The County Executive has said the jail will be opening for visitors and programs, and we hope to hear more about this soon.

Regional Justice Center in Kent: There are currently no in-person meetings allowed. Staff at the RJC are looking at setting up Zoom capability, however there is no timeline for this either.

Helen B. Ratcliffe Womens Work Release Center in Seattle: The facility is being remodeled and is now scheduled to open October 1st. They are committed to having womens in person meetings. If you are interested in service at this facility, please send an email to volunteercorrections@gmail.com.

Minutes of September 2022 GSIG Office Committee Meeting

Tuesday September 13th, 6:00PM via Zoom

Attending: Committee Chair Jeff U, GSIG Treasurer Carl G, GSIG Chair Astri, GSIG Office Manager Lara R, Jennifer L, Bill S, and GSIG Assistant Office Manager Anita S

GSIG Treasurer presented the August financial report. \$5000 under budget for the month due to one-time expense for new insurance premium, and three payrolls rather than two in the month.

Discussion of closure of Sno-King Intergroup, with no decisions taken pending outreach from the people involved in closing down.

Discussion of concerns about meetings not following traditions and about recourse available to members and GSIG. Clarified that members can always bring concerns to the Board for consideration by the groups.

Discussed upcoming rotation and open positions next term of GSIG officers and on the Office Committee. Encouraged all to help seek candidates for both.

Office Manager (Lara R.):

Financial: We have secured our new insurance policy as of September 1st.

Inventory: We have received the two literature items that you all voted on at the Spring Assembly. Please come and get some for your groups or districts.

I have opted to eliminate the plastic bottles in the office and rent a water cooler. This expense will be about the same as buying cases of water, and much easier on the recycling can.

I was able to attend the ICOAA Conference in Denver, CO a couple of weeks ago. It was an amazing experience. I got to attend a candlelight meeting at the oldest Clubhouse west of the Mississippi-the

York Street Clubhouse. Beautiful place, I highly recommend it if you ever get to Denver.

It was a real privilege to meet Bob W., the current Manager of the GSO office in New York, along with the current AAWS Board Chair. They gave a report of things that are happening at the office currently. GSO will re-open to visitors in early October. Everyone is very relieved about that. They are returning to the office to work in person now. They talked about some changes to the printing of the books which will make things more expedient in the delivery.

All of the Office Manager and the Board Chairs shared their best practices concerning all things Intergroup. I came away with some new ideas, but mostly I came away with a deep sense of gratitude for all of the Boards and Office Managers that have gone before that have made the structure of our office and how it works so seamless and highly functioning.

Accessibility (Laurel W.):

We need committee members. It's just me. I focus on ASL access only. We need people interested in serving others (non Deaf) who face barriers to getting to meetings.

I'm grateful that there's good support and donations to the ASL fund. These funds pay for interpreters for AA meetings we had a separate raffle at the Intergroup picnic and raised \$502.00 for the Blue can (aka ASL can)

Corrections Committee (Amy):

Girls meetings are going well at the Juvenile facility. Boys meetings are prevented by staff shortages, which may be soon resolved.

Helen B Ratcliff Women's Work Release facility is opening back up on October 1st and do want in-person meetings again. We will follow up next month.

The Federal Detention Center has opened back up and we are bringing meetings there. We badly need more committed women volunteers that can be patient to go through the process.

At SCORE, women's meetings are going well, with 2-3 volunteers each week.
