we feel Gratitude at depth for our sobriety, it is impossible to fall back and dwell in the merciless obsession to destroy ourselves with the alcohol and drugs that for so long haunted our existence. In Gratitude, we are safe and protected. A day that we are grateful, is another day sober.

Even in times of trouble, we can find a nexus to Gratitude by simply making a list, mental or on paper, of the simplest things. Upon awakening, we can reflect on the fact that we had a warm place to sleep or that we have food, health or friends. That we have the capacity for Love and have friends that love us.

No matter how unsettled our life may seem, if we can find something to be grateful for,

Step 11: "Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for knowledge of His will for us and the power to carry that out."

I can't pinpoint the exact day prayer AND meditation became can indispensable part of my daily spiritual practice, but I'm sure it was about a year-plus into my current sober run, which spans 1,388 days as I write this.

I found it much easier to make prayer a part of my morning routine, it fit in nicely with my coffee habit, I was not going to do anything without either. I place my phone under my bed overnight, so I have no reason to skip prayer when I'm on my knees.

But meditation was alien to me. I feared I had broken the parts of my brain and soul required to achieve it due to drinking and using.

Of course the problem was me, especially my expectations. I was expecting it to be easy. I was disappointed my head filled with all kinds of random thoughts the moment I was wanted to clear the mental decks.

I needed the help of a friend, who reminded me a habit of meditation is called a practice. He said I would get easier with time, but most of all, I had to seek improvement with gentleness toward myself. Random thoughts are always going to compete for our attention.

I let my temper flare when thoughts of dinner or an appointment with my dentist or a golf tee time bounced to the top of my consciousness.

He urged me to set a length of time goal as well as a fixed time to practice. He said sit quietly and when random thoughts intruded, as they always will, to return to my meditation targets gently

It really helped to have more realistic expectations. I no longer thought I'd be hearing shimmering sounds or see a light show on my eyelids. I was happy to be where my feet were. I sensed my HP's presence knowing in that moment I was OK. I felt serene.

Gradually, I went from trying to meditate five minutes at a time to 30 minutes over the course of six months. I used to skip meditating if I didn't have thirty minutes. Now I'll go for five minutes if that's all I have. Any meditation time is better than no meditation.

TRADITION 11: "Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films."

I used to be baffled by the Traditions, didn't think they applied to my recovery. I thought they were distracting from my rookie efforts to live a sober life until I realized they are rooted in the shared experiences of all those who preceded us in AA. Literally forged from the blood, sweat, tears and mistakes of other alcoholics.

The Steps show us the path to a life that is happy, joyous and free. The Traditions are our rules of road. Adherence to the Traditions is the easier softer way.

Tradition 11 keeps our groups on track to fulling our primary purpose, which is carrying AA's message to the still suffering alcoholic. Period. It also reminds me that its my actions, not my thoughts, intentions or words, that are the most effective means to deliver that promise.

As one of my favorite members used to say, repeatedly, "People would rather see a sermon than hear one!

NOVEMBER IS GRATITUDE MONTH!

Here are some reflections on Gratitude from some members of Alcoholics Anonymous.

GRATITUDE PAVES WAY TO PATIENCE, GROWTH

Grateful to the High & Dry for this opportunity to share on the topic of Gratitude. Most of all, today, I am grateful for the ability to let go and let God. I have listened deeply this past year and benefited from a broader range of meetings and additional program work. My faith and trust in HP working in my life is replenished. As I surrender to the fact that some decisions are beyond my control, I am learning more about patience.

I am grateful for our literature. District 15's support of writing workshops for the pamphlet, A.A. for the Black & African American Alcoholic, informed my panel talk at the Area 72 Assembly. As shared at the Spiritual Breakfast talk given by the Pacific Regional Trustee Reilly K., at the Assembly, our

literature expands on the solid backbone of the Big Book and the 12 x 12m, and crucially, will be how those of us who never heard Bill speak will carry the message of A.A. Our literature is the entry point for the still-suffering alcoholic, and I am grateful for efforts underway to create and expand inclusion.

Gratitude is the ability to accept and return kindness. I am recalling the share in a recent Daily Reflection, "The Main Taproot," about cherishing the memory of one's first meeting. My memory is of two men crossing the room at the break, loping toward cowering-me, to say, "Welcome, we're glad you're here." I repay that kindness by being of service. Contributing financially what I can; standing for positions; shaking newcomer's hands or calling on them in online meetings.

Grateful for being able to listen and learn, to have friends I have never met in person. I sense a continuity with the alcoholic who read the Big Book, wrote a letter to the Foundation, and then waited weeks or months for a return letter. Grateful for the lineage that is one alcoholic talking with another: that when I say, thanks, to my sponsor for something I notice I shared with a sponsee, he says, we follow in the steps of those who went before us.



GRATITUDE > **FEARS**

Feeling grateful for my life and what I have is dependent on how connected I am to my Higher Power. For me trust and acceptance battle with my fears and desire for control.

If I haven't prayed or meditated for a couple of days, I start feeling annoyed with my life and the people in it. I start feeling afraid that I don't have enough money, "thinness," accomplishments and so on.

Working daily for spiritual fitness is in my own best interests. Praying and meditating, practicing our 12 Steps of AA and calling my sponsor all help me keep the fear at bay.

Recently I've been experiencing periodic episodes of severe abdominal pain. I've seen my doctor and am waiting for a test result. It will get figured out and treated. Today, I'm grateful for being alive and having health insurance. Not much fear is in play at the moment and I'm grateful to AA for that!

GRATEFUL FOR MY SPIRITUAL PRACTICE

I always resisted the spiritual part of Alcoholics Anonymous, which is why it took me more than 30 years to get three-and-a-half years of continuous sobriety (my sober date is Jan. 7, 2019).

I had to be tricked into adopting a daily spiritual routine. The credit goes to my sponsor for insisting I pray every morning from my knees and send him a gratitude list (in the morning), and to my Higher Power, which has shown me that a consistent spiritual practice will be rewarded.

You could say looking reasons to be grateful was the best idea I never had.

My sponsor did not tell me why I needed to prayer daily and write a "grat" list. He just suggested doing it and I was so desperate and miserable, I tried it.



When my sponsor asked me to pray and provide him a list I was two days sober and I thought I had damn little to be grateful about. My marriage was over, my spouse had moved out, we were going straight to divorce and would sell our house, meaning I needed to find another place to live.

I was battered and beaten physically, mentally and emotionally from drinking and using.

I was incensed by my sponsor's suggestion (pronounced demand) for a gratitude list. How was praying and listing things I was grateful for going to solve my problems? I was massively shocked and pleased to find after less than two months how much I had to be grateful for.

I was alive. I was sober. I was feeling and sleeping better. The fog in my brain was clearing. I was going to meetings, I was lurching like a toddler as I began to work the Steps and I could see rays of hope on the horizon.

I am filled with Gratitude that my life is improving. I am grateful to still be in the game and learning to live life on life's terms, one day at a time. I've learned that the harder I work on my spiritual practices, which includes daily doses of meditation and service work, the more Gratitude I feel.

Many years ago one of our members attended a meeting in Las Vegas that had Pink Cans for people to contribute funds to cover literature expenses for people behind bars. He loved the idea so much he brought it back to Seattle and now we do it too!

So far in 2022, numerous groups have donated \$1100.95 through their Pink Cans. All the money is given to the GISG Corrections Committee to use to purchase literature. To date, Corrections has used \$995.51 to purchase literature for the Juvenile Detention Center, SCORE Facility, King County Jail, and to correctional facilities in Western Washington.


