April in our History

"Never could we recapture the great moments of the past." (BB, page 151). But here we list some.

April 1

1939 — *"Alcoholics Anonymous,"* AA's Big Book was published.

1966 — Sister Ignatia died at the age of 77.

April 7

1941 — Ruth Hock, Bill W's secretary, reported there were 1,500 letters asking for help, as a result of the *Saturday Evening Post* article by Jack Alexander.

April 10

1939 — The first ten copies of the Big Book arrived at the office Bill shared with Hank P. in Newark, New Jersey.

April 11

1938 – Alcoholic Foundation held its first meeting.

April 16

1973 — Dr. Jack Norris, non-alcoholic Chairman of the AA General Service Board, presented President Richard Nixon with the one-millionth copy of the Big Book at the White House.

April 22

1940 — Bill W. transferred his Works Publishing Stock to the Alcoholic Foundation.

April 23

1940 — Dr. Bob wrote the Trustees to refuse Big Book royalties, but Bill W. insisted on them for Dr. Bob and Anne.

April 24


1989 — Dr. Leonard Strong died. He was Bill!s brother-in-law and a non-alcoholic AA Trustee.

April 25

1951 — AA!s first General Service Conference was held.

April 30

1989 — The film, "*My Name is Bill W.*," a Hallmark Hall of Fame presentation, was broadcas to on ABC TV.

THERE HAVE BEEN FEW TIMES IN MY SOBRIETY

where I thought I was on the path of recovery, but later found out I was sliding back towards a drink. My most recent moment happened at 24 years sober. We had recently moved to a new city and I was busy with little kids at home. I found a women's Big Book meeting that I liked. It became my homegroup and also a source of friends and fellowship in this new city. I attended other meetings for the first few years, but after a while, they all became inconvenient and I was only going to my Monday night homegroup. During those first few years, I was also busy with sponsees, but one by one they moved on and I soon had none. Around this time, I began to get resentments against my homegroup members. The oldtimers didn't want me to bring my kids and that meant expensive babysitters or nights when I just couldn't attend. I felt resentful and sorry for myself and no one was asking me to sponsor them. Don't they know how wonderful I am? The meeting was also



getting smaller and smaller without a lot of new members. Pretty soon I began dreading Monday nights and didn't want to go to this meeting or any other.

One night a newcomer repeated something she had heard from an AA speaker. I don't remember what she said but I remember speaking to her afterwards and asking who the speaker was. It was Earl H. She brought me his CD (we used CD's back then) the following week. Listening to him made me wake up. Here was the program of recovery. Here was the message of hope. My current program did not resemble this at all. I felt scared.

I called a friend of mine who had originally told me about this "Monday Night Big Book Meeting," but had recently left to attend another. I said, "I think my sobriety is in trouble" and told her what was going on. She lovingly suggested I attend her new homegroup which met on Mondays and Wednesdays. Of course, I had a lot of excuses as to why that was not convenient, but

I went that following Wednesday. She walked me around and introduced me to the old-timers and some newcomers. I was home. Everyone who shared, shared the program of recovery. Their experience, strength and hope was like a healing balm. I felt safe and protected and so very relieved. I made that group my homegroup that first night and have been an active member ever since.

Even though I had strong sponsorship, thorough step work, and decades in the rooms of AA without a drink, I was and will always be an alcoholic. What I have is a "daily reprieve contingent on the maintenance of my spiritual condition." (Big Book page 85). My recovery from past years helped me realize my recovery at that point was in trouble, but it didn't protect me from slipping away. I needed to hear the message and actively work my program on a daily basis.

It's been nine years since I joined this new homegroup. Today I have many sponsees and feel like a useful group member through service and consistent participation. I see homegroup members at meetings throughout the city and pay close attention when I don't want to go because that means something is wrong with my spiritual condition. I've learned it's much easier to stay on the beam of recovery than to get back on once I fall off. I will be forever grateful to that newcomer who saved me by sharing her experience, strength, and hope. I will be forever grateful for the old-timers who are on the AA speaker's circuit and my friend who lovingly reached out her hand when I needed the hand of AA to be there.



Step 4: "Made a searching and fearless moral inventory of ourselves"

IT SEEMS LIKE THERE IS

A LOT OF FEAR, uncertainty, and sometimes confusion around Step Four. I've heard different people share different ways of 'doing' it with their sponsor, and have heard vastly different experiences of it.

When I say, "doing Step Four," I'm referring to the specifics of how a sponsor suggests their sponsee structure and write out their resentments, what is included, etc. For the purposes of this exploration, I'm not going to discuss or comment on the 'different ways' of "doing things."

Instead, I'm going to share a suggestion I was given, which has stuck with me.

Before I sat down to go over my Fourth Step with my sponsor, somebody else in the program – who I look up to – said something that has forever stuck with me. His suggestion was this: "There are going to be two or three things you really don't want to share with your sponsor, and those are the only things that matter."

Now, I'm not sure this suggestion is an absolute, and it might not pertain to everyone, but it sure did resonate with me, and seems to resonate with others in the program who have heard it.

And you know what, that guy was right.

Taking a fearless moral inventory of, and sharing things with another person I thought I'd take to my grave, felt great.

But it didn't happen right away.

There were things I left off my first Step Four – some on accident because I forgot, and some because I didn't think they were relevant. In reality, I was probably just fearful.

Then, just before my threemonth birthday, I relapsed.

Now, was the relapse directly related to my lack of sharing some things on my Step Four? A result of feeling guilt and shame?

I'm not sure. Maybe, maybe not. But my guess is that it certainly didn't help.

So, I went back and conducted a more thorough and complete Step Four with my sponsor.

I don't think I felt the immediate and powerful 'white light' relief wash over me, that some people talk about.

But there was, and still is, tremendous relief and connection stemming from Step Four. Specifically, it's powerful to have fearlessly shared the details of my life with another person.

Now, I'm very grateful to have just collected my 18-month coin, and still share resentments with my sponsor, or somebody else, as life comes up.

When and if I don't, I'm probably exercising a lot of self will, and can feel it affect the health of my recovery.

And I don't know about you, but I really want to trudge the Happy Road of Destiny.

Tradition 4: "Each group should be autonomous except in matters affecting other groups or A.A. as a whole."

FOR ME, the way AA groups operate is a Bad News/Good News situation. The bad news is every group is autonomous, while the good news is every group is autonomous.

After the founding of AA, many groups freely experimented with how meetings were conducted. Through trial and failure, groups found out which things worked or didn't. They recognized mistakes and changed practices as appropriate, mostly without rancor.

Tradition Four in the "Twelve Steps And Twelve Traditions" is the result of real-world experiences, some of them painful.

One doesn't have to attend many meetings to hear tales of this group or that which divided and spawned another group due to heated disputes about what should or should not happen at meetings. The only requirements for a new meeting are a couple of drunks, a coffee pot and a resentment or two.

In AA's maturity, it may seem like your group is very set in its ways (OK, rigid as a concrete slab). I experienced frustration when, as a newcomer, I'd hear, "We don't do things that way here at the Main Street group" before/ during/after business meetings when changes are suggested.

I was once told by one of our trusted servants, with decades of sobriety, when I persisted in telling them how I'd improve our homegroup's meetings, "There's a reason why there are more than 13-hundred meetings each week in the Seattle area."

The great news is there is an array of meetings and all of them are part of AA. Which reminds me of one of my favorite AA cliches: "There's a wrench for every nut in AA."

For instance, groups are free to choose which prayers are used to open or close a meeting (or no prayer at all). A meetings details are determined by each group locally, not the General Service Office in New York.

I always have the option of looking for a meeting that fits me better. (For the record, I did not leave my previously-mentioned homegroup. I chose to practice acceptance, albeit imperfectly at times, and go with the group conscience.)

The chapter on Tradition Four in the "Twelve and Twelve" is one of my favorites. It's one of the shortest and it's lessons are among the easiest to understand and practice.

My biggest takeaway is that I am, as an alcoholic, prone to overthinking and complicating everything, to my detriment. I'm extremely self-centered and tend to dig in to protect my opinions and fears. The same principle applies to the collective thinking and actions of AA groups.

In my early days in my homegroup, I was given a coin I still carry elder stateswoman: "Don't take yourself too damn seriously."

Hospitals & Treatment (West C)

The H & T Committee met on Saturday, March 4th @ 10 am and we have a bunch of exciting projects coming up:

- I started working with Union Gospel Mission's Riverton Place, a men's treatment facility in D31 at the beginning of 2022 and have been bringing a men's speakers meeting to their facility every month since then. They started bringing a van full of men to our Monday night OPP meeting in Burien. I recently met with one of their Chaplains and they expressed interest in us starting a monthly step study there as well. I donated 10 more books to them from our big book drive we held 4th quarter of 2022.
- I decided to expand our relationship with Union Gospel Mission so I visited Hope Place women's recovery facility in D15 last month. I met with the director and assistant director, donated a case of Big Books to them and they showed me around the entire facility. We had our first panel there on March 7th. It was myself and Jill P who kicked things off. They were allowing men to come speak there as well but have since changed their policy so I was the first and last. Jill has since arranged transportation for some of the women to come to her home group, Sober Sisters in Burien.
- D31 is teaming with our online D25 to carry 5 Zoom meetings weekly into Cascade Behavioral Health. They are closed to in-person visitation for the foreseeable future.
- West and Dave B (our online D25 Treatment Chair) shared our experience, strength & hope with Lakeside Milam Renton on the Final Friday of February. We are alternating with Eastside Intergroup every month on this joint venture to support their patients.
- I visited Fredy Cortez, SUD Director at Harborview's Psychiatric Unit last month and toured the facility while donating 10 Big Books. Fredy has given Danny & I the green light to begin the registration process and we both submitted our vaccination records. We hope to start carrying the message to their patients in April. I just heard from Debra Loft, their Volunteer Coordinator, and we are ready to fill out the volunteer paperwork.
- Seattle Medical Post Acute Care (SMPAC) is looking for a new group to bring a meeting into their facility. I reached to "Knuckleheads," a very active men's group on Capital Hill about the possibility of supporting this request. However, SMPAC has been on COVID lockdown so I am currently trying to reach them to check on their status.
- Virginia Mason has also expressed interest in us bringing an information panel for their staff as well as support for their patients in Recovery. We hope to bring a panel there in May.
- Jon Bridgman has expressed interest in our team supporting his Recovery Place women's Zoom panels on first & fourth Monday nights.
- I reached out to Key Recovery in Tukwila about bringing a panel in there but haven't heard back yet.
- I just received an e-mail from Salvation Army close to T-Mobile Park about bringing in a meeting there as well.


