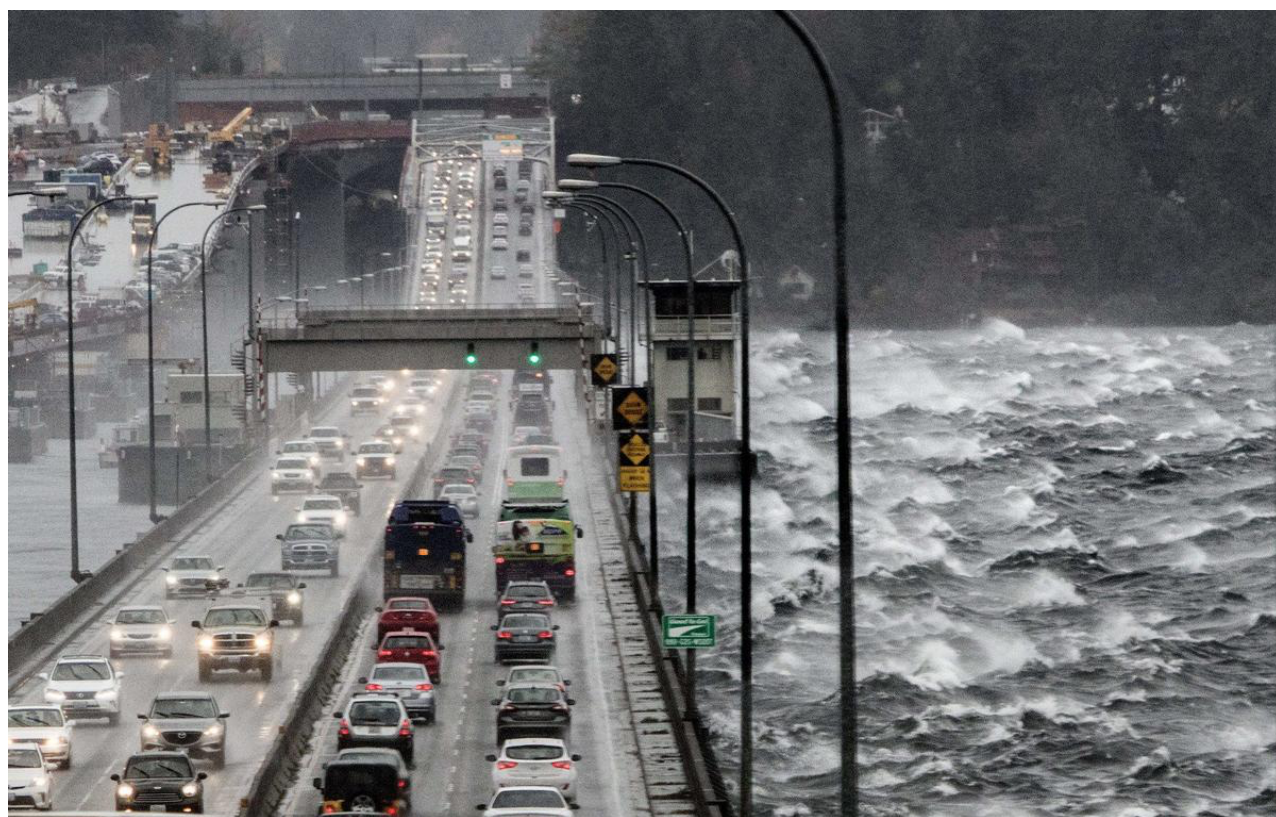

JUNE IN OUR HISTORY

June 1

1949 – Anne S., Dr. Bob’s wife, died.

June 6

1979 – AA gave the two- millionth copy of the Big Book to Joseph Califano, then Secretary of Health, Education, and Welfare. It was presented by Lois W., Bill’s wife, in New York.

June 8

1941 – Three AA’s started a group in Kalamazoo, Michigan.

June 10

1935 – The date that is celebrated as Dr. Bob's last drink and the official founding date of AA. There is some evidence that the founders, in trying to reconstruct the history, got the date wrong and it was actually June 17.

June 11

1945 – Twenty-five hundred attend AA's 10th Anniversary in Cleveland, Ohio.

June 16

1938 – Jim B., "The Vicious Cycle" in Big Book, had his last drink.

June 17

1942 – New York AA groups sponsored the first annual NY area meeting. Four hundred and twenty-four heard Dr. Silkworth and AA speakers.

June 19

1942 – Columnist Earl Wilson reported that NYC Police Chief Valentine sent six policemen to AA and they sobered up.

June 21

1944 – The first Issue of the AA Grapevine was published.

June 26

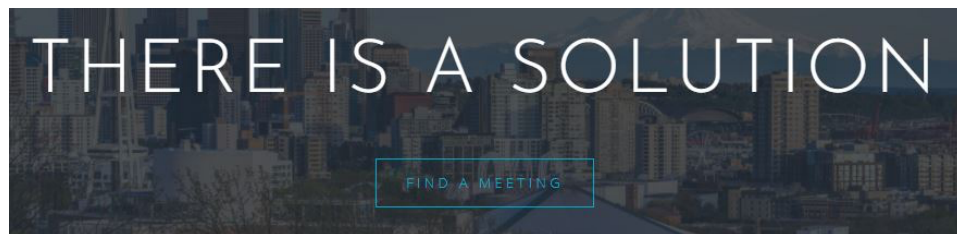
1935 – Bill D. (AA #3) entered Akron's City Hospital for his last detox and his first day of sobriety.

1935 – Dr. Bob and Bill W. visited Bill Dotson at Akron's City Hospital.

Step Six: *“Were entirely ready to have God remove all these defects of character.”*

In reflecting on Step Six, the saying “sometimes quickly, sometimes slowly,” really comes to mind.

In the “Twelve Steps & Twelve Traditions,” there are two sentences in the sixth chapter that read:

“Having been granted a perfect release from alcoholism, why then shouldn’t we be able to achieve by the same means a perfect release from every other difficulty or defeat? This is a riddle of our existence, the full answer to which may be only in the mind of God.”

This brief passage is both powerful, frustrating, and calming all at once.

Why doesn’t God simply remove all my other defects and difficulties!?

Well, the “Twelve Steps & Twelve Traditions” goes on to offer some discussion on that question, but in my near two-year experience in these rooms, falling back on the idea of “sometimes quickly, sometimes slowly,” seems pertinent.

With time, continued practice of these Steps, and letting go and letting God, I’m finding that “sometimes quickly, sometimes slowly,” rings true in relation to my difficulties and defeats being removed.

When I look back, even just a few months, I often find that life is much more peaceful, serene, and good now than it was then. So, something must be working.

It was, and often still is, difficult early in AA to deal with the challenges of life. “Why can’t they all go away?” I sometimes ask myself. “What is wrong with me? Why isn’t life perfect right now?”

When feeling this way, I find solace and comfort in turning to those with more time than me. In my experience, I’ve been hard pressed to find an old-timer who doesn’t

seem to have the serenity, peace, and connection that I want. This reminds me, that with time, life continues to improve, and I'll continue to let go of my defects, difficulties, and pains.

This is a welcome observation, however frustrating (I'm an alcoholic after all, and I want to change the way I feel now!), and reminds me that while I don't experience a perfect release from "every other difficulty or fear right away," life gets better and better over time, and I am not alone in this experience.

It sure is *a lot* better than when I was drinking – it's categorically different, and I'm so thankful for that.

With surrender, rigorous honesty, and continued service, I have faith that God may not always give me what I want, but he'll give me what I need.

Another take on Step Six: *Loving Courage*

When thinking about Step Six, the greatest obstacle for me was knowing my defects in the first place. Where am I stepping on the toes of my fellows? I see clearly where they are retaliating, what isn't always clear is my part. Steps One through Five showed me the baseline problems in my make up. I am self-centered, full of fear, try to control the world around me and want to run the show. Steps Ten and Eleven remind me, daily, of where I stepped off the beam and where I might in the near future. Here is an example of how this works in my daily life.

My son is 16 and a sophomore in high school. Academic excellence is not important to him. Wonder where he gets that!? While my own high school achievements were not important to me, his success is. So much so that I have pushed him to the point of fighting, creating low self-esteem, teaching him his efforts are not good enough, and creating stress and tension in our household. I knew this was a struggle, but I didn't see the truth about my behavior until he told me how he felt and I saw that I was harming him. I really believed that if I just tried harder and kept at him, I would help him succeed. I was so very wrong.

My best thinking created harm. I knew I must change my behavior. In order to change this behavior, and have God remove my defects, I needed to be willing to experience the vulnerable fear that he might fail. The horrible possibility that I have failed him. That is hard to walk through. Denial, justification, rationalization,

and self-righteousness feel much more powerful and comfortable. Feeling powerless and vulnerable takes guts. Courage comes from love. My love for him is more powerful than my fear of vulnerability. My love for him gives me courage to be wrong. My love for him gives me willingness to go to God for help. The 12 Steps having provided me with a working relationship with a Power that solves all my problems.

So here we are at the end of the school year and he is at risk of failing two classes. As I read the emails from the teachers, my heart started beating faster, the adrenaline started pumping and I started practicing my conversation with him of all the things I was going to take away from him and all the consequences he would have if he didn't focus and make improvements. Then I paused. I've been practicing what I call a Breath Prayer. One big breath, not really any specific ask, but just practicing being with God. I left my computer and all these emails from the teachers and went on with my day. When I saw him after school, I had an intuitive thought. It said: "Why don't you ask him how he wants to handle this situation?"

So I did. We had a loving exchange and conversation. He had wonderful and manageable solutions. We had a fantastic evening and our home was joyful. Thank God. I am profoundly grateful for this work that really works. I have found a Power in my life that solves all my problems. My job is to see the truth about myself and have the loving courage to be wrong.

Tradition Six: An AA group ought never endorse, finance or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property and prestige divert us from our primary purpose.

For me, it's laughable that we need Tradition Six. It would be obvious to anyone attending my home group that the prospects of success for any business connected with us would be slim to infinitesimal.

But the Traditions of A.A. are the result of our shared experiences, which were often painful as well as disappointing. As a group, A.A.'s are down with giving virtually anything a try. YOLO, baby!

In our beginning, enthusiastic A.A.'s wanted to share the miracle of recovery with as many people as possible (pronounced lots of money needed to make connections). Groups organized hospitals, treatment centers, schools, clubhouses and the like.

It's written on page 159 of Twelve Steps and Twelve Traditions: *"These adventures implanted a deep-rooted conviction that in no circumstances could we endorse any related enterprise, no matter how good. We of Alcoholics Anonymous could not be all things to all people, nor should we try."*

None of the ventures succeeded. The efforts conflicted with our primary purpose, which is to share the message of recovery with suffering alcoholics. Profits and losses, business plans and visions, and conflicting opinions doomed these sincere efforts to help others.

We are complicated people who do best when we keep things simple.

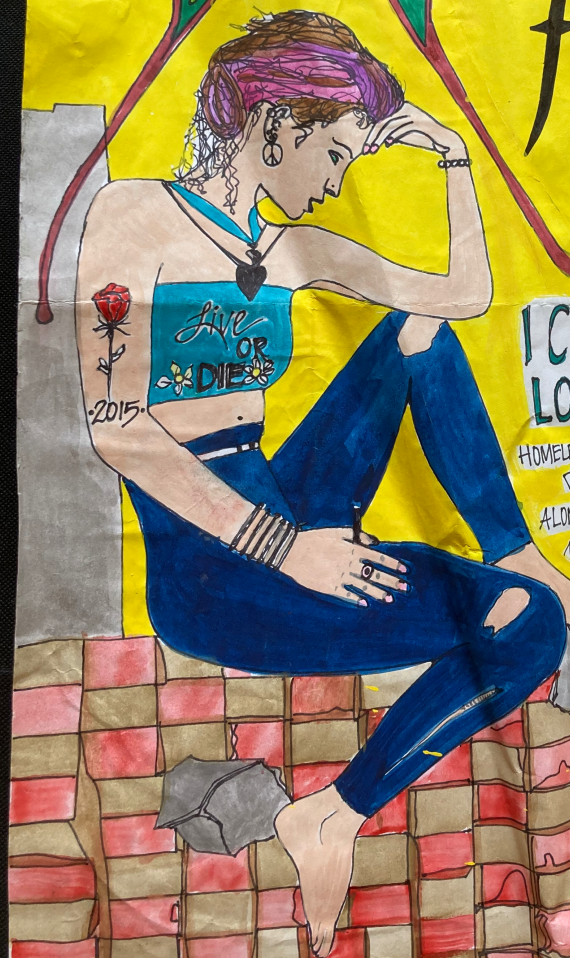

Carina, our PI/CPC Chair asked me to help her coordinate manning a GSIG Table at the King County Substance Use Disorder Conference, held at Bellevue College on Thursday, May 11th. I was joined by: Karla L, GSIG Board Chair; Josh B, GSIG CPC Alt Chair/Dist. 17 CPC Chair; Jane S, Dist 34 Past CPC; Laura D, Dist. 24 CPC Chair; Sunny O, Dist40 CPC/PI Chair; Greg S, Dist. 24 GSIG Rep and Bobby T, Trusted Servant. They were all a great representation of AA; I was proud and grateful for the example they set. I had a great time fellowshiping and learning a little about what is happening in the “substance use disorder” community and current treatment focus appears to be. We did have some attendees

(politicians, treatment providers and recovering people) approach our table and avail themselves of the literature (and candy) provided at our table.

Thank you, Carina, and GSIG for the opportunity to continue to serve. It was a good day.

GSIG OFFICE REPORTS

- **Office Manager (Lara Office Manager) –**

Financial: Group contributions are up; individual contributions are up but still lagging behind budget and the Sustainers Program is above budget. Thank you for your support. We have purchased a new desktop computer for only \$100! This computer runs the Point-of-Sale System. The old one was getting very slow.

Inventory: Our inventory is good, however, GSO continues to be on backorder for certain books and pamphlets. There is a new edition of the Grapevine book: The Home Group: the heartbeat of AA. They ought to be in by month's end.

- *Procedure:* We have ordered picnic buttons. Our normal source is no longer available, so we had to order buttons through another avenue. That ought to be in by the end.
- Our Special Events Committee has begun to ask for help from Districts. Not a lot of response yet, but hopefully as Districts have their monthly meetings there will be more activity on the Sign-up Genius.
- We are working on setting up a chat feature on our website. This will be a great opportunity for service soon. More to come.

SERVICE COMMITTEE REPORTS:

- **Accessibility (Laurel)-**

The Accessibility Committee is very active in serving Deaf alcoholics. We currently coordinate interpreters for AA meetings and other activities such as outreach for the committee.

Tomorrow I will visit District 16 business meeting to discuss the

committee and the blue can. If your district has any surplus after paying expenses and contributions, please consider inviting me to your district meeting on how you could support the blue can. The blue can, aka ASL can, is paying for interpreters for the Duck Island group (in District 17). This group is interpreted every Monday (in person). The blue can also pays for the interpreter for the Speaker meeting last Saturday at Pass it On. Sometimes it's challenging to find an interpreter available on a Saturday night in the Normandy Park area, hence some Saturdays are not filled. But regular Deaf attendees are notified of changes. Chairperson and interpreter coordinator for the Accessibility Committee

- **Archives: (Teresa)**

This is the first time since January 2020 that somebody has held the Archives position. I attended

the Area 72 Archives Quarterly Meeting. This was very helpful since we haven't seen each other for a very long time. One of the items that keeps coming up is, digitization. Ideally, archivists, the hardcore ones want stuff that is still saved in paper, hard copies. But we've been working closely with the area to share information. And if we have some documents that are area specific, I was able to take some of those and give them to the area archivists for the first time in three years. It was good to be able to get back to quote normal. And I think, Lara mentioned and that there's some new displays in the display cases.

There's a collection of books. They're called the Golden Books by Father John Doe. That's obviously not his real name. They are not conference approved literature, but they're fascinating materials. I thought it would be a good idea to have them on display. They are, they have all of them that we have, we have about 20 of them. They're all stapled on the end with ugly, corroded staples. I take all the staples out and rethread them with white thread like this. I'm in the process of

rethreading them now. This is part of what archivists do, is take out staples and rethread books.

- **Corrections: (Amy F)**

Greater Seattle Intergroup will tentatively be hosting the Area 72 Summer Quarterly meeting on Saturday, June 17th. Zoom info and other details to be posted soon

- **Hospitals & Treatment: (West)**

The Hospital & Treatment Committee last met on Sat, May 6th at GSIG @ 10am and on Zoom with 16 people in attendance.

We continue to work with Union Gospel Mission's Riverton Place in D31, a men's treatment facility and I am working on getting some new guys involved.

We have expanded our relationship with UGM to include Hope Place, a women's recovery facility in D15...We continue our monthly panel there.

D31 also continues to carry 5 Zoom meetings weekly into Cascade Behavioral Health. They are closed to in-person visitation for the foreseeable future. I met with the director last month and he says everything is fine on their end. He said he could use some more big books so I donated a case from our H & T budget and dropped them off last week.

Our next Lakeside Milam Renton panel will be on the Final Friday of June 30th @ 9 am. We are still alternating with Eastside Intergroup every month on this joint venture to carry the message to their patients.

My sponsor Danny & I had our first panel on Sun, May 7th @ 5:30 pm at Harborview Psychiatric Unit and I will be going back with our own Janet

A. this week. We have 5 new volunteers going through the process of being approved so we can increase to weekly panels.

We also started a men's meeting at Salvation Army's William Booth Center on May 7th @ 7 pm and donated more books from our Big Book Drive.

We will be starting to bring Veterans from the program to speak at the VA Tuesdays at noon.

A few of us have been speaking at "Intercept" via zoom a treatment center in Federal Way courtesy of Robert, the D32 Treatment Chair.

In addition, we plan to host our next Area Treatment Quarterly in July hybrid at GSIG.

The best way to get involved in any of these projects is to attend our monthly hybrid H & T Committee meeting on the first Saturday of every month. We meet at 10 am at the Seattle Intergroup office and also on zoom.
