



ONE OF THE BIGGEST LESSONS I

LEARNED by doing the 12 Steps of Alcoholics Anonymous is that self-centeredness is the root of my problems. If I am not self-centered, I really don't have many problems. I discovered that fear leads to self-centeredness. Fear of not getting what I want, fear of losing something I have, and fear of rejection or humiliation. My defects became very clear in Steps Four and Five..

Most, if not all, of my defects are useful in granting me a false sense of control and security. The question then becomes, how do I stay out of this self-centered fear? My sponsor shared that the way she changed her behavior was to practice the opposite and be of service for others. Thankfully, AA's structure makes it easier for me to practice random acts of kindness throughout the day.

Practicing the opposite was a little harder. I was having a hard time being honest, being generous and trusting that I was going to be OK.

My sponsor then suggested my least favorite prayer of all time, the one asking God to deflate my ego. In fact, I hated this prayer and did not want it to come true and faked it when I was praying (and truly hoped God wasn't listening). This is literally what I have been trying to avoid my whole life and now she wanted me to pray for it! I wanted what she had, so I was willing to do what she did. Willing doesn't always mean want to. In fact, I can really not want to do something, and be willing just the same. I said the prayer every day.

Here's where the miracle happened. When I would receive ego deflation during the day in the form of getting someone's name wrong and being embarrassed or tripping when I walked into the room (feeling I looked foolish) or making a big mistake at work, I no longer felt the pain of humiliation. Instead, I felt like God was in on it and if God is in on it, and listening to me and walking with me through this day, maybe it's all going to be ok.

"I used to react to my ego being threatened as if my life was being threatened," I heard that in a meeting once and it's true for me. Those situations would have been devastating in the past. When I'm walking through life trying to protect my ego and your opinion of me, I am dishonest, manipulative, full of fear and extremely self-centered. I step on the toes of my fellows and they retaliate.

I feel lonely and confused as to why no one wants me around. When I'm walking through life knowing the God of my understanding is walking next to me and the world is accepting me and all my imperfections, I can be honest, vulnerable and focused on you!

Life is full of love and laughter and being comfortable in my skin. Ego deflation is actually a relief!

FROM PERSONAL EXPERIENCE, while not the most 'recovery-centric' on its surface, Tradition Seven has been quite important in my recovery, and others may agree.

First off, the fact that I was neither required to pay a dime, nor expected to contribute financially to AA allowed me, as a newcomer, to at least for a moment put aside hesitations or questions I may have had

about the intentions of a 12 Step program like AA, and focus on sobriety.

Beyond the protection and confidence that the Tradition offered me as a newcomer, it also seems to protect the program, as a whole, from outside dependence and influence.

Tradition Seven, at the end of the day, is a cornerstone of my recovery, even if I don't always recognize it. And it is one that, while short, sweet, and to the point, helps create space in the fellowship for my recovery, and I hope for my fellow's recovery, too.

For that, I am grateful.


Rude Awakening

Research needed to begin, but joining AA's Corrections Correspondence Service pays benefits to everyone involved

I FOUND MY WAY INTO CORRECTIONS CORRESPONDENCE SERVICE tin much the way I have learned a lot of things in Alcoholics Anonymous. I was doing my duty of making announcements about the opportunities in Corrections (few of which I have actually done yet) at an online group and someone reached out to me in the chat with a question.

As is my response to most questions that I don't know the answer to, I responded, "That's a GOOD QUESTION." I used to feel very put upon when people would ask me for more information about things that I announced at meetings. I would think that they should be able to figure it out for themselves and didn't they know that I was too busy to do the research to answer silly questions that I didn't know the answers to?

Experience has taught me that if I don't have experience with something first hand, I should probably do a little research and reach out to others who DO have that experience. I went to the GSO website at aa.org and printed out a CCS Form. It took only a few minutes to fill out, then I emailed it to corrections@aa.org. In about 90 minutes, I got a personal response from our AMAZING Corrections Chair Eileen, who I had recently heard speak at a service event, and she that let me know that there was a waiting list for women.


I was honestly relieved that I was off the hook and didn't actually have to do anything more! About 5 days later, I received not one, but TWO names of women who had filled out Insider Request Forms for CCS. I was afraid I would do it wrong, so I carefully read and used the AA guidelines for CCS and wrote my first two letters to persons in custody.

I was able to report back to my friend with some answers regarding their questions about service, and I have been even received a letter in response from one of the women. When I received the letter, an immense feeling of gratitude came over me. After reading the letter, I had the same profound experience as I have had hearing a Fifth Step.

This fellow alcoholic in custody had helped me in a way I didn't expect. I would highly recommend volunteering for CCS as one of the many ways to Carry the Message.


