

#### REFLECTING ON OUR PAST

#### **December In Our History**

"Never could we recapture the great moments of the past." (Alcoholics Anonymous, page 151). But here we list some.

Dec 1934 Bill & Lois start attending Oxford Group meetings.

Dec 1934 to May 1935 Bill works with alcoholics, but fails to sober any of them. Lois reminds him HE is sober.

Dec 1938 Twelve Steps written.

Nov/Dec 1939 Akron group withdrawals from association with Oxford Group. Meetings moved from

T Henry & Clarence Williams to Dr Bob and other member?s homes.

Dec 1939 First AA group in mental institution, Rockland State Hospital, NY.

Dec 1939 1st home meeting in Los Angeles at Kaye M.'s house.

Dec 1939 Matt Talbot Club has 88 members, uses wagons to collect old furniture to recondition & sell,

not A.A., used A.A. program, material, marked 1st effort reach alcoholics outside married

middle-class category.

Dec 1940 1st AA group formed in St. Louis, Missouri.

Dec 1940 Group started Ashtabula, Ohio due to Plain Dealer articles. A.A. Cleveland has about 30 groups.

Dec 1948 Dr. Bob's last major talk, in Detroit.

Dec 1950 Grapevine article signed by both Bill and Dr Bob recommend establishing AA General Service

Conference.

Dec 1955 'Man on the Bed' painting by Robert M. first appeared in Grapevine.

Painting originally called 'Came to Believe'

Dec 1982 Nell Wing retires from GSO after 35 years of service.

Dec 1, 1940 Chicago Daily Tribune begins a series of articles on AA by Nall Hamilton.

Dec 5, 1985 Dave B, founder of Montreal Group dies weeks before 50th anniversary.

His story added to the 4th Edition Big Book.

Dec 6, 1939 Bert the Tailor lends Works Publishing \$1000.

Dec 6, 1979 Akron Beacon reports death of Henrietta Sieberling.

Dec 7, 1949 Sister Ignatia received Poverello Medal on behalf of A.A.

Dec 10, 1975 Birds of a Feather AA group for pilots is formed.

Dec 11, 1934 Bill admitted to Towns Hosp 4th/last time (fall '33, '34 in summer, midsummer and

final admittance).

Dec 11, 1941 Dallas Morning News reports 1st AA group formed in Dallas.

Dec 12, 1934 Bill has Spiritual Experience at Towns Hospital.

Dec 12, 1937 Bill meets with Rockefeller Foundation and tries to get money.

Dec 13, 1937 Rockland State Mental Hospital takes patients to meeting in New Jersey.

Dec 13 or 14, 1934 Ebby visited Bill at hospital, brought William James's book, "Varieties of Religious Experience".

Dec 19, 1939 Los Angeles hold their 1st AA meeting there.

Dec 20, 1945 Rowland H dies (he carried the Oxford Group message to Ebby).

#### The Twelth Step

WHEN I COMPREHENDED all that was entailed in practicing Step 12, I balked. I was completely self-centered and did not want to put out any effort to help others.

I thought keeping me sober was my most important job.

But my persecutive has changed over time (and literally thousands of meetings). Thanks to the examples of others, work with my sponsor and many sponsees, I recognize the need to give away what was freely given to me, namely, sharing my experience, strength and — our primary purpose at members of AA.

It is clear to me now, that my sobriety relied on the help, support and love of others.

Step 12 requires me to practice the principles of the first 11 Steps in all my affairs.

I started a part time job in August at a residential substance abuse treatment center that is immensely more enjoyable when I do my utmost to practice AA's principles in all my contacts with newly sober alcoholics and addicts.

On many days, my unconditional love of my fellows is exhausted before my first break.

It took me longer than it should have to recognize the things they did that upset me were things I hated about myself. That I've made mistakes that hurt myself and others, that I'm impulsive and extremely emotional, that I've behaved insanely, that I am not perfect.

I now have a prayer and meditation practice before beginning a shift, in my car in the parking lost) that helps me get past lunch time with a more positive approach. (So grateful for Step 11.)

I can see that my sense of joy, happiness and freedom has been enhanced by mindful attention to Step 12, especially my ability to forgive myself and others when my exceptions collide head-on with my expectations.  $\triangle$

**A HALLMARK** of 12-step recovery programs is the offer of anonymity to participants, but the principle goes much deeper than just not revealing last names. This is Tradition 12, "Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles above personalities."

To keep the focus on principles rather than personalities, personal anonymity should be maintained at all levels of participation in 12-step fellowship—in meetings, in 12th step work, and even in sponsorship.

Anonymity is maintained not so much for the protection of the individual as for the protection of the program. Reflections from those in a 12-step program provide a glimpse of the underlying principle of this tradition., even the best, do the same. As individuals, we have sometimes believed that the public use of our names could demonstrate our

personal courage in the face of stigma, so lending power and conviction to news stories and magazine articles.

But these are not the allures they once were. Vividly, we are becoming aware that no member ought to describe himself in full view of the general public as an AA, even for the most worthy purpose, lest a perilous precedent be set which would tempt others to do likewise for purposes not so worthy.

We see that on breaking anonymity by press, radio, or picture, any one of us could easily transfer the valuable name of Alcoholics Anonymous over onto any enterprise or into the midst of any controversy.

So it is becoming our code that there are things that no AA ever does, lest he divert AA from its sole purpose and injure our public relations. And thereby the chances of those sick ones yet to come.

To the million alcoholics who have not yet heard our AA story, we should ever say, "Greetings and welcome. Be assured that we shall never weaken the lifelines which we float out to you. In our public relations, we shall, God willing, keep the faith."  $\triangle$ 



#### Doing the Work is Key to AA Success

#### WHEN I WAS FIRST INTRODUCED to

Alcoholics Anonymous in the mid-1990s, my attitude was trash, so were my results.

Unlike many AA members I've met, who knew nothing about our 12 Steps of recovery before joining, I attended my first meetings with extensive knowledge of what people in recovery had to do to succeed.

I knew it took work to make AA's promises a reality, lots of work, and that was a problem for me. The amount of work required freaked me out, just like one of my favorite 1960s TV characters, Maynard G. Krebs of the sitcom "The Many Loves of Dobie Gillis." Younger AA members may not know who Maynard was.

FROM WIKIPEDIA: "The Krebs character, portrayed by actor Bob Denver (Gilligan of "Gilligan's Island"), begins the series as a stereotypical beatnik, with a goatee, "hip" (slang) language, and a generally unkempt, bohemian appearance. ... He is always banging out a modelrn jazz beat with his hands, to music in his head ... His abhorrence of conventional social forms is signified by comical reactions to three words: "work," "marriage," and "police." For example, whenever the word "work" is mentioned, even in passing, he yelps "Work?!" and jumps with fear or even faints."

That was my reaction to hearing about the work required to become happy, joyous and free, AA style.

I didn't want to do it. It was too hard. And I thought I wasn't worth the effort. Attending thousands of meetings has convinced me otherwise.

Two of the most important people in my life and recovery — my dad (John Peoples Sr.) and my best friend (Bob B.) — didn't just tell me "How It Works." They showed me.

When my dad died four years ago, he was a month shy of being sober 50 years. Bob, who I first met playing little league baseball, celebrated 41 years this past April.

Of course, it took me nearly 30 years since from my first meeting to get an appreciable length of sobriety. As I write this, I have more than 1,700 consecutive days (4.9 years). My sober date is Jan. 7, 2019.

I had an "attitude" problem when I came to AA. I instantly recognized I had much in common with the folks in the rooms, but I still resisted the idea of admitting I belonged in AA — as a member.

I didn't want to do the work I saw Bob and my dad do to get and stay sober. I wanted the pain, fear and loneliness in my life to end, but I only wanted to work on recovery in my spare time.

I didn't want to follow the Steps. I didn't want a sponsor, but most of all I did not want a Higher Power. I was still hooked on finding solutions that looked easy and fast (pronounced half measures).

I wasn't able to act on words encouraging me to choose another path in life. I could not deny that my dad and Bob had drastically turned their lives around by working on AA's principles in all their affairs, but ...

I could see why THEY needed AA's brand of help. I, however, was convinced that I did not. I wasn't as bad as they were. If I had done the things they did — DUIs, divorces — then I'd be ready for AA. I could not see that AA and the Steps were for me — until I could see it for myself..

It took more research, finding a higher level of pain and misery, to convince me that AA offered me a way out that would work — IF I is was willing to do the work.

I was on a losing streak in the game of life — my significant other was on my case 24/7, I was struggling at my job and relations with many relatives and friends were fraying or icy. I had frequent, painful hangovers, but that was just the price paid to have "fun," as I defined it.

I thought the world and the people in it were at fault. I just needed time to figure things out. I was convinced I could get it together on my own. No need for something as drastic as AA, which required effort, attention to detail and accountability (one day at a time).

I had to be forced, by a sense of desperation, to even try working the Steps as written. I only surrendered when I believed my situation was hopeless if I didn't follow AA's suggestions.

I'd hung out enough AA meetings to finally recognize that it was my thinking that got me to the rooms of AA.

Once I surrendered, AA stopped looking like a chore and I could see that it offered solutions.  $\triangle$


